

**57th ANNUAL NATIONAL COUNCIL MEETING (ANCM)
OF THE BOY SCOUTS OF THE PHILIPPINES (BSP)**

1. Pursuant to Republic Act (RA) No. 7278, the Boy Scouts of the Philippines (BSP) will hold its **57th Annual National Council Meeting (ANCM)** on February 19-22, 2013 at the Philippine Scouting Center for Asia-Pacific Region, Mt. Makiling, Los Baños, Laguna.
 2. The ANCM aims to:
 - a. know and receive reports of the National President and the National Treasurer;
 - b. elect four regular members of the National Executive Board;
 - c. receive amendments to the BSP By-laws;
 - d. conduct the National Court of Honor; and
 - e. hold the Awarding Ceremonies for the Tribute to the Scoutmaster 2013, Ten Outstanding Local Council Chairmen and Ten Outstanding Local Commissioners.
 3. The participants to the ANCM are the BSP National Executive Board Members, DepEd Officials involved in Scouting, Council Chairmen, Local Council Scout Executives and other Local Council Officials representing the 117 Local Councils and ten Scouting Regions of the BSP.
 4. The participants from the Department of Education (DepEd) are authorized to attend **on official business**. The Three Thousand Five Hundred Pesos (P3,500.00) registration fee covers meals except breakfast, conference kits and souvenirs. Registration fee, accommodation, transportation and other incidental expenses to be incurred by participating DepEd officials and personnel shall be charged to local funds, subject to its availability and the usual accounting and auditing rules and regulations.


SUBJECT : UTILIZATION OF PUBLIC FUNDS RELATIVE TO ATTENDANCE IN CONVENTIONS, SEMINARS AND SIMILAR ACTIVITIES CONDUCTED BY THE ASSOCIATIONS OF PROFESSIONALS, FOUNDATIONS, NON-GOVERNMENTAL ORGANIZATIONS AND OTHER ORGANIZED GROUPS

Department Memorandum Circular No. 96-167 dated September 5, 1996, entitled, *Policies and Guidelines on the Utilization of Local Funds Relative to the Conventions, Seminars and Similar Activities Conducted by the Associations of Professionals, Foundations, Non-Governmental Organizations and Other Organized Groups*, is hereby repealed.

It is understood that any in-country convention, seminar or training attended by a local government official or employee, with the use of public funds, is within the purview of the Capability Development Agenda of the participating local government.

It is further understood that a Provincial Governor, City Mayor, Municipal Mayor or a Punong Barangay, as head of a local government, is principally responsible and accountable for the prudent use of scarce financial resources keeping in mind desired organizational results and development outcomes.

This Memorandum Circular shall take effect immediately.
