SUBJECT : **SEMINAR ON NEW GOVERNMENT ACCOUNTING SYSTEM (NGAS) AND OTHER PERTINENT COA RULES AND REGULATIONS AND SIGNIFICANT UPDATES ON FINANCIAL ASSISTANCE PROGRAM (FAP) OF THE BSP FOR REGIONAL OFFICE STAFF AND LOCAL COUNCIL STAFF**

In consonance with the objective of the Boy Scouts of the Philippines (BSP) in improving the level of capabilities and upgrading the knowledge and skills of its ranks, the BSP management has scheduled and prioritized the conduct of a seminar on New Government Accounting System (NGAS) and other pertinent rules and regulations of the Commission on Audit (COA) in February to April 2015. Such strategic measure is a continuing commitment of the management to empower BSP employees to cope up with the ongoing transition in the operational system of the BSP from a private organization into a Government Owned and Controlled Corporation (GOCC).

The significant changes on the BSP Membership Registration Process and Reporting System, as circulated through National Office Memorandum No. 53 dated August 29, 2104, will be given emphasis and be discussed thoroughly in the aforesaid seminar. Furthermore, significant updates on the Financial Assistance Program (FAP) of the BSP shall also be tackled in the said seminar in order to maximize the presence of the targeted participants.

As agreed during the conference on Enhancing the 2015 Annual Work and Financial Plan, the seminar will be conducted as follows:

Each local council or region is allowed to send a maximum of two (2) participants only.

The participants to the aforesaid seminar are the Regional Scout Directors, Regional Field Scout Executive, Registration Officers, Council Scout Executives, Field Scout Executives, Registration Officers and/or Finance Officers. All participants are expected to arrive a day before the seminar and shall leave after fully attending the said event.

A minimal registration fee of Five Hundred Pesos (Php 500.00) shall be collected from each participant. All other expenses relative to the event shall be borne by the BSP National Office chargeable against its budget for MOOE. The RSDs shall make the necessary arrangement on the respective venue of each cluster including the accommodation of the participants and the resource persons.
