 - e. MR. GERONIMO D. TOLOSA, ALT as Dep. National Program Commissioner for Boy Scouting
 - f. MR. BERNANDO G. DE LEON, LT as Dep. National Program Commissioner for Senior Scouting
 - g. MR. WILFREDO A. PABUAYA, LT as Dep. National Program Commissioner for Rover Scouting
