SUBJECT: 56<sup>th</sup> ANCM RESOLUTIONS

- 1. As presented during the 56<sup>th</sup> Annual National Council Meeting held on 16-18 May 2012, at Camiguin Convention Center, Mambajao, Camiguin Province, the following Resolutions were fully adopted and duly approved by the National Council for your immediate compliance and implementation.
- 2. The basic information of the Resolutions are as follows:

### A. RESOLUTION NO. 1 – REQUIRING ALL LOCAL COUNCILS TO ORGANIZE AND REGISTER COMMUNITY BASED SCOUTING UNITS BY 1<sup>ST</sup> QUARTER OF 2013.

- All Local Councils through the leadership of the Council Chairman and the Council Commissioner must see to it that at least one Community-based Scouting unit is organized and registered by 1<sup>st</sup> quarter of 2013 and should be reported to the National Executive Board by the Regional Chairman.
- 2. Council Scout Executives must draw out plans as part of the Membership Growth and Recruitment Strategy to ensure that this Resolution is implemented.

# B. RESOLUTION NO. 2 - ADOPTING THE CWTS SCOUTING PROGRAM BY 1<sup>ST</sup> QUARTER OF 2013.

 The Boy Scouts of the Philippines was accredited by the Commission on Higher Education and TESDA as Service Provider of NSTP/CWTS. The need for offering Rover Scouting in Colleges/Universities is of vital importance to prepare the youth for service towards creating a better world.

- As such, vigorous campaign must be done by Local Councils to promote the CWTS-Scouting Program and ensure the registration of Rover Circles in colleges and universities within their territorial jurisdiction. Local Council Executive Board are required to prepare a plan of action and should see to it that every sponsoring institution adopts the CWTS- Scouting program by 2<sup>nd</sup> quarter of 2013.
- 3. Council Commissioners and Council Scout Executives are advised to organize a Task Force or Committee to conduct visitation and orientation to promote NSTP-CWTS Scouting in all colleges and universities within their Council territory.

# C. RESOLUTION NO. 3 - REQUIRING ALL LOCAL COUNCILS TO ORGANIZE EMERGENCY SERVICE CORPS

- Our country is frequently visited by typhoons and experience a lot of natural
  calamities, thus, the Boy Scouts of the Philippines must be in the forefront of relief
  operations and emergency service to victims of disasters. Senior Scouts and Rover
  Scouts shall be trained with the basic skills and equipped to respond to the call of
  service during calamities.
- 2. The Council Chairman, Council Commissioner and Council Scout Executive must see to it that a functional Emergency Service Corps shall be organized not later than first quarter of 2013.
- 3. All Regional Chairmen is required to report on the implementation of these Resolutions to the National Executive Board from time to time.
- 4. For information, guidance, widest dissemination and strict compliance.
