SUBJECT : RELIEF OPERATIONS FOR THE VICTIMS OF SUPER TYPHOON YOLANDA

Super Typhoon Yolanda pummelled through the central part of the country, triggering 12 to 15 feet high storm surge, flooding and landslides that resulted to over 10,000 deaths, huge number of injured and affected close to six million people. The typhoon victims urgently need safe water to drink, food supply, medicine and shelter. This super typhoon further worsened the destruction caused by the 7.2 magnitude earthquake that heavily damaged the province of Cebu and Bohol in Visayas last October 15, 2013.

The Boy Scouts of the Philippines – National Office is conducting relief operations by repacking rice, canned goods, instant noodles, biscuits, instant coffee and collecting other basic needs such as clothes, blankets, mats, tents and other related items for distribution to those who were affected by the super typhoon. We are now accepting voluntary donations (in cash or in kind) so that together, we can help alleviate the plight of the victims.
