

**SUBJECT : NOMINEES FOR REGULAR BOARD MEMBERS OF THE NATIONAL
EXECUTIVE BOARD**

1. As stipulated in the Boy Scouts of the Philippines (BSP) Constitution and By Laws, Article V Section 5. *Information on Nominees*. All proposals for nomination shall be submitted in writing to the Committee on Nominations for its recommendation so as to be received by the Committee at least four (4) weeks prior to the opening of the National Council Meeting. This Committee shall be given full information concerning all possible candidates. During the deliberations of the Committee, it shall meet in an executive session, and on request of any member, voting for nominees for the National Executive Board may be by secret ballot.

This committee shall submit a list of nominees *containing not less than twice nor more than thrice the number of positions to be filled*. Nominations on the floor may be allowed by majority vote of the members of the National Council present at the meeting, provided that such person nominated on the floor has been previously nominated but not considered by the Nominations Committee.

2. The Committee on Nominations, in fulfilment of the above provision, convened last April 21, 2014 to receive the nomination forms and review the qualifications of all candidates to run for the slots of four (4) regular membership and 15 private sector representatives. The following nominees for regular membership to the National Executive Board (NEB) have been accepted by the Nominations Committee, to wit:
