**NATIONAL OFFICE MEMORANDUM**

**TO :** Regional Scout Directors, Council Scout Executives and Officers-In-Charge

**SUBJECT :** SUBMISSION OF BID FOR THE HOSTING OF THE PHILIPPINE SCOUTING CENTENNIAL JAMBOREE

1. In line with the upcoming celebration of the **100 Years of the Introduction of Scouting Program in the Philippines**, the Centennial Celebration Committee, of the National Executive Board is in the process of planning and organization of the Philippine Scouting Centennial Jamboree which will be held in three (3) geographical locations in the country on the following dates to wit:
  - a. Luzon: 5 – 9 November 2014
  - b. Visayas: 7 – 11 November 2014
  - c. Mindanao: 9 – 13 November 2014
2. In view of this, the National Office, BSP through the Centennial Celebration Secretariat invites all interested Local Councils to submit their application to bid the hosting of the Philippine Scouting Centennial Jamboree specifically for Luzon and Visayas, while the venue for Mindanao, as approved by NEB, will be held at the Zamboanga Special Economic Zone, Zamboanga City.
3. All interested local councils are expected to submit the following:
  - a. Letter of Intent signifying your interest to host the event duly signed by the Council Chairperson, Council Commissioner and Scout Executive;
  - b. Minutes of the Meeting and Board Resolution indicating the approval of the Local Council Executive Board the application to bid the hosting of the jamboree;
  - c. Letter of Support from your Local Government Unit;
  - d. Letter of Support from your Local DepEd Division Office;
  - e. Endorsement from the Regional Office duly signed by the Regional Chairperson; Regional Scout Commissioner and the Regional Scout Director;
  - f. Brief description and specification of the proposed Jamboree camp site indicating its exact location/address; and
  - g. Letter of Authority from the land owner in case of private property indicating the permission to use the area as jamboree campsite during the dates of the jamboree including necessary camp preparation and site development.
4. All communication must be addressed to MR. ROBERTO M. PAGDANGANAN, Chairman, Centennial Celebration Committee, through ATTY. WENDEL E. AVISADO, SVP and Acting Secretary General and Attention to MR. ROGELIO S. VILLA, JR., Head, Centennial Celebration Secretariat, National Office, BSP.
5. All applications to bid the hosting of the said event must reach the National Office, BSP on or before **18 July 2014** for appropriate action of the Centennial Celebration Committee.
6. Attached here is the National Office Memorandum No. 16 series of 2014 on the Guidelines for Hosting and Conducting a Scout Jamboree which will form part of the criteria for the awarding of bid to participating local councils.
