**TO : REGIONAL SCOUT DIRECTORS, COUNCIL SCOUT EXECUTIVES AND OFFICERS IN-CHARGE**

**SUBJECT : GUIDELINES FOR THE FULL RETENTION OF THE LOCAL COUNCIL REGISTRATION SHARE (LCRS)**

Pursuant to Section 1 of Article XVII of the National By-Laws of the Boy Scouts of the Philippines and the decision of the National Executive Board (NEB) to dissolve the National Fund for Council Operation (NaFCO) **effective 01 January 2016**, which was duly confirmed and approved by the National Council in the 59<sup>th</sup> Annual National Council Meeting held in Tagum City on May 20-22, 2015, **ALL LOCAL COUNCILS (LCs) WITHOUT FINANCIAL LIABILITY TO THE NATIONAL OFFICE** shall retain, in addition to the P10.00 share of the Local Councils the additional amount of P4.00 representing their NaFCO share or a total amount of P14.00 representing the **Local Council Registration Share (LCRS)** from the membership fees effective 01 August 2015.

The attached Local Councils with negative NaFCO balances shall continue to remit their NaFCO share until their outstanding balances shall have been fully settled.

This development is expected to improve the financial condition of the LCs with the end in view of empowering the LCs to manage their own financial resources while promoting transparency in their operations.

It is understood that the full amount of LCRS retained by the LCs is deposited intact and properly accounted for in the books. Attached is the LCRS schedule for your reference.

All issuances inconsistent with this Memorandum are hereby rescinded.
