3. Qualification of Participants:

Scout Applicants

- Duly registered Boy and Senior Scouts
- At least First Class Rank Holder for Boy Scouts and Venturer Rank Holder for Senior Scouts
- Must be physically fit and in good health
- The Scout must have attended BSP Regional/National Scout Jamboree

Adult Leader Applicants

- Duly registered with the Boy Scouts of the Philippines
- At least five (5) years experience as a Unit Leader, preferably Woodbadge holder
- Must be physically fit and in good health
- The Unit Leader must have attended BSP Regional/National Scout Jamboree

Mode of Selection: The National Office, BSP reserves the right to select the members of the delegation based, firstly on qualification and secondly, on a first reservation acceptance basis.

Based on international standards, the jamboree composition is one (1) adult leader for every nine (9) Scouts, the approval of adult application will be dependent on the total number of participating Scouts.

All prospective participants attending international jamboree MUST attend the prejamboree training to be conducted by the BSP National Office.
