3. The timetable for the Selection of the Outstanding Local Council Chairman, are as follows:

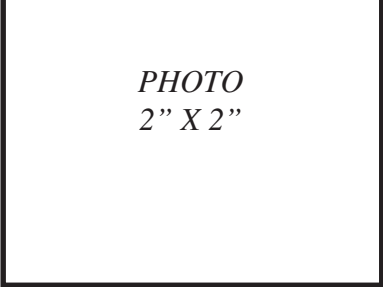
7 January	-	Deadline for submission of entries at Regional Level.

19 February	-	Awarding Ceremony during the conduct of the 57 th ANCM, Makiling, Los Banos, Laguna.
