SUBJECT: IMPORTANT INFORMATION ABOUT THE 16<sup>TH</sup> NATIONAL SCOUT JAMBOREE

[1] SPECIAL JAMBOREE NECKERCHIEF AND T-SHIRT[2] VISITING SCOUTS AND SCOUTERS (DAY TOUR)[3] REPORTING TIME OF THE NATIONAL SERVICE TEAM

[4] EXTENSION OF THE REGISTRATION

In line with the holding of the 16<sup>th</sup> National Scout Jamboree at the Energy Park, Apokon, Tagum City, Davao del Norte on 24-30 October 2015, all concerned are hereby informed as follows:

1. **Special Jamboree Neckerchief and T-Shirt.** To emphasize and make significant the experience of the young people and adults in Scouting who will be participating in the Jamboree, the National Office has come up with the production of the Special Jamboree Neckerchief and T-Shirt in limited stocks only. The pricing of the said merchandise are stated below:

Special Jamboree Neckerchief PhP 110.00 Special Jamboree T-Shirt PhP 120.00

For Local Councils who are interested to buy any of the above-stated items, you may place your orders directly to the National Scout Shop through the Sales and Marketing Manager, Ms. Myles Edna B. Orders must be place in bulk only, and must be faciliated by the Local Council Office.

2. Visiting Scouts and Adult Leaders (Day Visitors). The Jamboree will be exclusive only to those who have duly registered with the host council and with the National Office – Scouts, Unit Leaders, Accompanying Adults and Contingent Management Teams, and members of the National Service Team. As an ancillary feature of the Jamboree, the National Jamboree Organizing Committee has included a DAY TOUR during the said event, in order to accommodate the parents, guests and other friends of Scouting who would want to see the programs of the Boy Scouts of the Philippines (BSP).

The day tour is scheduled on **27 OCTOBER 2015, Tuesday from 0800H until 0500H**. A minimal fee of **TWO HUNDRED PESOS (PhP 200.00)** will be collected per Visiting Scout or Adult Leader which is inclusive of a Jamboree ID Card, Jamboree ID Lace and a Special Neckerchief for day visitors.

Day visitors are only to stay inside the camp during the period specified above and are only to observe the delivery of the Jamboree programs and the conduct of the activities. They are not to stay beyond the period specified.

The Regional Offices and the Local Councils are advised to facilitate the registration of their respective day visitors, following the regular registration procedure for the Jamboree, as stipulated under National Office Memorandum Nos. 42 and 47, Series of 2015.

3. Reporting Time of the National Service Team. In order to ensure the competent and efficient delivery of the programs of the Jamboree, the members of the National Service Team are hereby required to report at the Jamboree site not later than 1000H of 21 October 2015, Wednesday instead of 23 October 2015 as previously stated under Item 9.2 of National Office Memorandum No. 42, Series of 2015. They are to stay at the Jamboree site not later than 1300H of 30 October 2015, Thursday.

The members of the National Service Team are to undergo skills proficiency test/trainings and prejamboree workshops prior to the actual conduct of the Jamboree. Members of the NSTs are to arrange their respective transportation to and from the Jamboree site. **They are also advised to bring their own tents and sleeping gears.** 

4. **Extension of the Deadline of Registration.** Recognizing the clamor and the requests of various Local Councils for the extension of the deadline of the registration for the Jamboree in order to allow them to be able to maximize the opportunity of the young people to join the Jamboree, the deadline of the registration for the Jamboree is hereby extended until 15 October 2015, Thursday.

There will be no further extensions beyond this date and the **No On-Site Registration Policy** for the Jamboree will strictly be enforced. Should there be any Local Council who would bring participants in excess of their actual registered participants, they will not be entertained.

The National Office had already given each and every Local Council ample time to facilitate the registration of their participants for the Jamboree. Furthermore, the submission of the registration must strictly conform to the requirements that need to be submitted – roster of participants and the corresponding deposit slips.

- 5. **Arrival and Departures.** In order to facilitate the entry and exit of the participants in all airports, seaports and terminals, all Regional Scout Directors are hereby directed to submit to the National Office the itineraries of their Local Councils, inclusive of the details of their arrival and the departure.
