what is the ANCM?

The Annual National Council Meeting, or shortly referred to as the "ANCM," is the annual corporate meeting of the National Council of the Boy Scouts of the Philippines. The participants of the Annual National Council Meeting are the members of the National Council composed of the members of the National Executive Board, the Regional Directors and Schools Division/City Superintendents of the Department of Education who are serving as the Regional and Council Scout Commissioners, officers of the ten (10) Regional Scout Committees, officers of the Local Council Executive Boards and other local officials representing all the duly chartered Local Councils of the Boy Scouts of the Philippines.

The Meeting is in accordance with pertinent provisions specified under Commonwealth Act No. 111, as amended by Presidential Decree No. 460 and Republic Act No. 7278 respectively, and with Article V, Section 1 of the National By Laws of the Boy Scouts of the Philippines which provide that:

'The National Council shall hold an annual meeting not later than May 31 of each year, at such time, date and place may be determined by the National Executive Board for the purpose of receiving the annual reports of the officers, electing the regular members of the National Executive Board, ratifying any proposed amendment to these bylaws and transacting such other business as may properly come before the meeting.'

At the ANCM, the officers of the National Executive Board, particularly the National President, the National Treasurer, the Chief National Commissioner and the International Commissioner render their respective reports to the National Council. During the Annual National Council Meeting, the National Executive Board also convenes the National Court of Honor in order to confer the National Higher Awards to its deserving members. The National Higher Awards include the Tamaraw Award and the Usa Awards classified into bronze, silver and gold, respectively. It also includes the Tanglaw ng Kabataan Award, President's Award, Mount Makiling Award, Lifetime Achievement Award, Honesty Award, Gallantry and Heroism Award, Scout Family Generation Award, Scouting Family Award, and other special awards and recognitions duly approved by the NEB.

Ancillary events during the said event are the Awarding Ceremonies of the Tribute to the Scoutmasters, the Outstanding Regional and Council Chairpersons and the Outstanding Regional and Council Scout Commissioners and the Lorillard Spencer Award for the Local Council performance.

PRE-COUNCIL MEETING ACTIVITIES

The 60th Annual National Council Meeting was hosted by the Provincial Government of Pangasinan and Pangasinan – San Carlos City Council with Governor Amado T. Espino, Jr. at its helm.

The Province of Pangasinan, the third biggest province in the whole Philippine Archipelago, derived its name from salt or "asin" in the vernacular. Owing to the rich and fine salt beds which were the prime source of livelihood for the province's coastal towns, PanagASINan or "Pangasinan" which means "where salt is made" came to be its name.

The province is crescent-shaped and occupies 536,818 hectares of land area which constitutes almost one-half (41.8%) of the total land area of Region 1 and 1.8% of the total area of the Philippines. Composed of 4 cities and 44 municipalities, it is bounded on the north by the Lingayen Gulf, La Union and Benguet, on the north-east by Nueva Vizcaya, on the east by Nueva Ecija, on the south by Tarlac, and on the west by Zambales and the West Philippine Sea.

Owing to its diverse cultural heritage rooted in centuries of glorious history and a way of life that is a delightful combination of tradition, innovation and creativity, the warm, polite, hospitable, hard-working and fun loving 2.65 million Pangasinenses (2007 census) enjoy the best of Provincial Philippines where you find both the familiar and unfamiliar world, abreast with modern technological times, but with a preserved vast panorama of outstanding natural beauty and unique attractions.

Pangasinan boasts of stretches of white, sandy beaches, verdant hills, scenic terrains, caves, waterfalls, ancient Hispanic churches, miraculous destinations for devotees, a vast coastline for fishing, water sports or leisurely walking along the Lingayen beach where one can get a glimpse of the world-famous Philippine sunset.

Being a gateway of sorts, the province is house to major and minor telecommunication companies, bus and transport services, regional and local publications, radio stations, television networks, cable services, hotel and restaurant chains, and a diversified variety of manufacturing and merchandising establishments.¹

The 60th Annual National Council Meeting was held at the Governor Teófilo L. Sison Auditorium located at the Provincial Capitol Compound, Maniboc, Lingayen, Pangasinan on 17-19 February 2016. Since the Auditorium houses only the conference hall, the participants to the Council Meeting were billeted in different hotels near the venue.

1. Meeting of the National Executive Board²

As a prelude to the conduct of every ANCM, the NEB holds a meeting few hours before the opening of the ANCM in order to finalize and discuss matters that will be presented to the National Council, for consideration, approval or appropriate action.

Convened at 1000H of 17 February 2016, the Regular Meeting of the National Executive Board was held at the Conference Hall of the Urduja House, the Official Residence of the Governor of the Province of Pangasinan.

2. Arrival and Registration

The registration for the 60th ANCM official started at 0800H of 17 February 2016. It was handled by personnel from the National and Regional Offices of the BSP headed by the Acting Director of the Finance Division, Mr. Pedro B. Penados.

Upon arrival, all participants confirmed their registration at the Sison Auditorium and went on to their respective hotels and resorts within the heart of Lingayen, Pangasinan.

For the 60th ANCM, each participant was assessed Two Thousand Pesos (PhP 2,000.00) as Conference Fee, inclusive of the meals, conference materials (kits, notepad, pen, 2015 BSP Annual Report, 59th ANCM Proceedings, National Office Memorandum No. 09, Series of 2016 re: Nominees for Regular Members of the National Executive Board and Election Rules and Regulations) and souvenirs.

It is also important to note that this is the first ANCM that has employed an online registration system, where all Local Councils were required to confirm their participation, inclusive with the total number of delegates, observers and accompanying persons and pay the corresponding fees ahead of time. The new system proved to be convenient on both ends as the participants were only required to confirm their arrival with the Conference Secretariat and directly check in to their designated hotels.

3. Assembly at the Conference Hall

As scheduled, the delegates started to convene at the conference hall by 1300H, in time for the pre-conference activities and orientation.

Prior to beginning with all the formalities of the ANCM, the Pangasinan Provincial Chorale rendered a spectacular presentation. Their performance was met with thunderous applause from the delegates.

Immediately after, the Officer of the Day, Regional Scout Director Bienvenido B. Toledo of Eastern and Western Visayas Regions requested everyone to settle down to begin with the order of the day.

4. General Orientation

In order to appraise the delegates and the guests of the basic house rules that will be enforced throughout the duration of the conference, DSG Rogelio S. Villa, Jr. gave the General Orientation and reiterated the following:

4.1. Basic Details

- 4.1.1. Each delegate is expected to attend all plenary sessions, listen to the different reports being rendered, and actively participate in the discussion/s.
- 4.1.2. The General Program of Activities will serve as the day-to-day guide for the series of events and activities that will be conducted during the duration of the Conference. Should there be any changes in the schedule, the announcement will come directly from the Officer of the Day.
- 4.1.3. The identification cards must be pinned at chest level at all times.
- 4.1.4. Meals will be ticketed and will only be served as scheduled. A 'No Meal Ticket, No Plate! Policy' will be enforced.
- 4.1.5. Be punctual. There will be a roll call before the start of every plenary session.
- 4.1.6. Each delegate must strictly conform to the attire for the day as stipulated in the General Program of Activities.

4.2. Mobilization

- 4.2.1. The mode of transportation in Lingayen, Pangasinan are tricycles. A minimal fee of ten pesos (PhP 10.00) will be charged per passenger per ride.
- 4.2.2. The Provincial Government of Pangasinan will be providing shuttle services to the participants on a first come, first served basis. The schedules of which will be posted at the lobby of the Sison Auditorium.

4.3. Conference Kits

- 4.3.1. The conference kits will be issued upon confirmation of registration. It will include the conference materials (kits, notepad, pen, 2015 BSP Annual Report, 59th ANCM Proceedings, National Office Memorandum No. 09, Series of 2016 re: Nominees for Regular Members of the National Executive Board and Election Rules and Regulations) and souvenirs.
- 4.3.2. Other souvenir items will be issued to the participants at the plenary hall from time to time. Distribution will be done on a first come first served basis.

4.4. National Court of Honor

- 4.4.1. The awardees for the National Court of Honor must confirm their attendance with the Awards Supervisor of the BSP National Office, Mr. Leon Carmelo G. Saliendra upon confirmation of registration. The policy on 'No Confirmation, No Award' will strictly be enforced.
- 4.4.2. The taking of photos during the National Court of Honor is highly discouraged so as not to befuddle the solemnity of the ceremony.

4.5. House Rules of the Sison Auditorium

All guests are informed of the following House Rules, in accordance with the General Terms of Services:

- 4.5.1. Smoking inside the Sison Auditorium is strictly prohibited.
- 4.5.2. Hammering of nails, screws, staple wires, tapes other materials or acts which may damage the wall, floor, stage and chairs/benches are not allowed.
- 4.5.3. Vandalism is strictly discouraged in the Sison Auditorium. Lessees who perform such act will be charged with a fine equivalent to the full payment of the damage.
- 4.5.4. Dragging of heavy equipment and other materials is discouraged to avoid the scratching of the Auditorium or stage floor.
- 4.5.5. At no time shall all doors or other egress paths be locked.
- 4.5.6. A production/event supervisor from the Sison Auditorium is required for all activities.
- 4.5.7. Backstage doors shall only used for VIPs, coordinators, hosts, performers and other important guests and shall not be used as audience or participant's entrance.
- 4.5.8. Only the Sison Auditorium personnel are allowed to control the air conditioning units.
- 4.5.9. Organizers/focal persons must coordinate with the resident electrician for the control of house lights.
- 4.5.10. It is the responsibility of the lessee to properly and safely move in and move out materials and equipment which are to be used during the event/occasion.
- 4.5.11. Prior to the event, the organizers should be notified if audio-visual equipment shall be used during the event.

- 4.5.12. Posters, tarpaulins, streamers, pylons, and others advertidising materials which need to be installed in the Sison Auditorium are subject to checking and approval of the Office of the Provincial Governor. Such materials shall follow standard sizes set by the Provincial Engineering Services and shall be installed in designated areas such as bulletin boards and/or tarpaulin stands.
- 4.5.13. Lessees may prepare or practice at the Sison Auditorium if and only if there are available dates upon verification. Only electrical bills will be charged.
- 4.5.14. Security Guards on duty are authorized to check all load-ins, bags and baggage brought inside the auditorium.
- 4.5.15. Lessee is responsible for the damages which may be incurred. Repair costs will be invoiced.

5. Recognition and Presentation of Guests and Conference Delegates

The Recognition and Presentation of Guests and Conference Delegates was facilitated by Engr. Rogelio S. Villa, Jr., Acting Deputy Secretary General and concurrent Director of the Field Operations Division of the BSP National Office.

Per record of the 60th ANCM Secretariat, a total of **SEVEN HUNDRED FORTY FOUR (744)**³ delegates and observers registered for the 60th Annual National Council Meeting covering **one hundred eight (108)** of the **one hundred twenty one (121) Local Councils** of the BSP. In summary, the ANCM was attended by **89.25%** of all its Local Councils across the country.

It was announced that Southern Tagalog Region has the most number of delegates among the ten Scout Regions with 153, while, Bulacan Council has the most number of delegates among all Local Councils with 82 delegates.

DSG Villa, Jr. reported to the body that the 60th Annual National Council Meeting hosted by the Provincial Government of Pangasinan and Pangasinan – San Carlos City Council have broken several records of previous ANCMs:

- The Annual National Council Meeting with the biggest recorded number of participants [delegates, observers and accompanying persons] – 744 participants, besting Tagum City Council's record of 657 participants.
- The only Annual National Council Meeting with 90% of the duly charted Local Councils represented.
- The first Annual National Council Meeting to ever utilize a Pre-Registration and Confirmation System, totaling veering away from on-site registrations.

Upon hearing all these new feats, the conference delegates loudly applauded the management, most especially the Provincial Government of Pangasinan and Pangasinan – San Carlos City Council headed by Governor Amado T. Espino, Jr.

Having covered all pre-conference matters, the Office of the Day, RSD Toledo then requested everyone to go back to their respective seats and settle down for the Opening Ceremony.

OPENING CEREMONY

The Opening Ceremony of the 60th Annual National Council Meeting commenced at 1430H. The Guest of Honor and Speaker was the Vice President of the Republic of the Philippines and the President of the Boy Scouts of the Philippines, Hon. Jejomar C. Binay. Joining him for the ceremony were Governor Amado T. Espino, Jr. of the Provincial Government of Pangasinan and concurrent Regional Chairperson of the Regional Scout Committee of Ilocos, Schools Division Superintendent Celia Junio Fernandez of DepEd Division of Pangasinan 1 and concurrent Regional Vice Chairperson of the Regional Scout Committee of Ilocos, including other senior officials of the National Executive Board.

The usual parts of the opening program were handled by the Pangasinan Provincial Chorale, along with some selected Scouts from Pangasinan - San Carlos City Council. The Regional Scout Representatives of Luzon and Visayas to the National Executive Board led the assembly for the Pledge of Allegiance to the Flag, the Rededication to the Scout Oath and Law, respectively.

In her Welcome Remarks, Superintendent Fernandez, representing Regional Director Alma Ruby C. Torio of the Department of Education Region 1, expressed her regrets that Regional Director was not able to make it for the Opening Ceremony as she was called at the Central Office of the Department of Education for equally important concerns. Nevertheless, she welcomed all the delegates with open arms, "On behalf of the Department of Education, we wholeheartedly welcome you to the Province of Pangasinan, and to Ilocos Region. We are very thankful that you have selected our beautiful province to this annual convention. You need not to worry, you are under the excellent care of Governor Amado T. Espino, Jr. You are in good hands."

Governor Amado T. Espino, Jr. also took the podium to welcome the delegates. "We welcome all of you to Pangasinan, most especially on the occasion of the Diamond Jubilee of the Annual National Council Meeting. Nakakataba ng puso, ano ho, because I was told that we have just broken the record of having the highest number of delegates in a National Council Meeting." He continued further, assuring the full support of the entire Provincial Government of Pangasinan over the course of the stay of the delegates in Pangasinan.

Immediately after, a Plaque of Recognition was presented to Governor Amado T. Espino, Jr. and Regional Director Alma Ruby C. Torio by Vice President Jejomar C. Binay and Acting Secretary General Wendel E. Avisado.

Hon. Roberto M. Pagdanganan, Senior Vice President of the Boy Scouts of the Philippines, was called up in front to introduce the Guest of Honor and Speaker. SVP Pagdanganan then introduced Vice President Jejomar C. Binay as Guest of Honor and Speaker.

"This will be my last message at the opening of our Annual National Council Meeting as President of the Boy Scouts of the Philippines, for by God's will and support, the next time that I'll be addressing you, I will already be your Chief Scout," Binay proudly stated as he began his Keynote Address.

The crowd went haywire, cheering loudly and indistinctly.

He continued, "Our 60th Annual National Council Meeting is a way of reminding all of us that Scouting is very much alive and shall continue to live as long as we continue believing. Yes, we BELIEVED and there is no reason why we should not survive."

Vice President Binay rallied everyone to always give their undivided best in fulfilling their responsibilities and in nurturing the young people.

Before he ended his address, he formally declared the opening of the 60th Annual National Council Meeting.

Prior to concluding the ceremony, Vice President Binay awarded the First Prize Winner (PhP 1,000,000.00) of the 2015 National Fund Campaign, Mr. Ryan B. Balares of Camarines Sur Council, Bicol Region.

The Master of Ceremonies, RSD Bienvenido B. Toledo then took over to effectively manage the photo opportunity with Vice President Binay. He then announced that the Welcome Dinner and Cultural Night Presentation will begin at 1800H at the Capitol Plaza, directly in front of the Provincial Capitol Building hosted by Governor Amado T. Espino, Jr. Attire is Smart Casual.

The Opening Ceremony ended at exactly 1528H.

Pagdanganan, Senior Vice President of the National Executive Board as the Presiding Officer. SVP Pagdanganan is also a *Member Emeritus* of the NEB.

The agenda for the 1st Plenary Session were:

- 1. Approval of the Proceedings of the 59th Annual National Council Meeting
- 2. Report of the National Treasurer
- 3. Report of the National President
- 4. Dialogue / Open Forum with the National President

Immediately after convening the session, SVP Pagdanganan wasted no time and went on with the agenda as calendared.

1. Presentation, Review and Approval of the Proceedings of the 59th Annual National Council Meeting

SVP Pagdanganan directed the conference delegates to go over and review the proceedings of the 59th Annual National Council Meeting held at Big 8 Corporate Hotel, National Highway, Tagum City, Davao del Norte last 20-22 May 2015. Prior to this, the Officer of the Day, Director Atinyao, had earlier informed the conference delegates to go over the proceedings in order to thresh out any matter that may arise from the proceedings. Moreover, the proceedings of the previous ANCM were included in the conference kits, and the same were circulated online via electronic mail more than a month prior to the conduct of the 60th ANCM.

A motion has been raised by a delegate from Misamis Oriental Council for the approval of the proceedings of the 59th Annual National Council Meeting. The motion was duly seconded, and hearing no objections and/or discussions on the floor, the motion was approved.

With no further discussions, the Presiding Officer commended the Conference Secretariat of the 59th Annual National Council Meeting for a very comprehensive proceedings of the previous ANCM, complete with all necessary appendices. The same was affirmed by the delegates with a loud applause.

2. Report of the National Treasurer⁵

The Presiding Officer then recognized Mr. Enrique B. Lagdameo, National Treasurer of the Boy Scouts of the Philippines to render the Treasurer's Report in order to provide the delegates with an update on the financial performance and condition of the BSP for CY 2015.

"As the New Year unfolds, a promising future for the Boy Scouts of the Philippines is ahead of us. While we certainly have our ups and downs, we persevered and hurdled every obstacle that keeps getting in the way. We rallied with our cause in encouraging the youth to become good citizens. We became more equipped with the capability to continue with our goals in

serving our country with competence and proficiency as can be gleamed from our past operations,"NT Lagdameo proudly began his report.

The report highlighted that total assets of the BSP as of December 2015 has increased by P22,027,498 or equivalent to 0.48%. The increase was from the aggregate results of the financial performance for the year 2015 with a total of P34,360,717 net of the obligations settled totaling P26,625,269 or equivalent to 19.90%.

He reiterated that remittances from the BSP-Alphaland Makati Place Project have started to come in, deposited directly in a separate account dedicated for remittances from the aforementioned Joint Venture Agreement.

Before he finally ended his report, Lagdameo stated, "We have now further strengthened and solidified the resources of our organization towards achieving growth and stability. We have continued to increase our membership and have started to reap the fruits of our investments."

After the report, SVP Pagdanganan requested the conference delegates to raise their questions during the open forum after the National President's Report in order to allow the senior officials of the NEB to render their reports first.

A gentleman from Misamis Oriental Council raised a motion for the approval of the Report of the National Treasurer. Hearing no objections, and having duly second, the Presiding Officer approved the report of the National Treasurer.

3. Report of the National President⁶ with Dialogue and Open Forum

Next on the agenda was the Report of the National President. However, the Presiding Officer informed the conference delegates that due to urgent matters of the state that warrant the attention of Vice President Jejomar C. Binay, he was unable to render his report to the National Council. Nevertheless, he has authorized Atty. Wendel E. Avisado, Acting Secretary General to render the President's Report on his behalf.

With this, the Presiding Officer then recognized Atty. Avisado for the Report of the National President.

Report on the BSP's Financial Position by NT Enrique B. Lagdameo

Prior to beginning of his report, Atty. Avisado requested NT Lagdameo to report to the National Council the current financial standing of the Boy Scouts of the Philippines. "I'd like to request again our National Treasurer, and through a [power point] presentation, our current standing insofar as our finances are concerned; because, the National Council has the right to know where exactly are our finances deposited, and what exactly is the current status," Avisado continued.

To this end, the Presiding Officer requested the National Treasurer to report to the National Council the current financial standing of the BSP, and as to which banks these finances have been deposited. "This is actually good, this will tell us precisely, where we are [in terms of finances] today."

The National Treasurer then acceded to the request of the Acting Secretary General.

"Okay. What is flashed on the screen right now is our current financial position [Financial Status Monitoring Report] as of 12 February 2016," Lagdameo stated.

After NT Lagdameo rendered the continuation of his report, SG Wendel E. Avisado then went on with the Report of the National President.

[&]quot;There you have it, ipinakita na ng ating National Treasurer ang ating kaperahan, because we want to assure you that our finances are in good hands. The members of the NEB are working hard to protect the interest of the BSP, lahat yan mga volunteers, they spend their own money just to get here, to attend meetings. All this, for the love of Scouting,' Avisado passionately said to the members of the National Council. This was met with a loud applause from among the delegates.

Report of the National President

"I want Scouting to be at the forefront of youth development as I pursue a dream that one day, Scouting would become a part of every young boys and girls life," Vice President Binay started.

"Again, I will tell you, the year 2015 is a year of growth and stability. We reached a milestone which, to us, is a proof of our commitment to serve and dedication to service — this is our greatest resolve, our success and yes, our triumph."

Vice President Binay focused his report on BSP's Major Final Output – Membership Growth. He related how BSP fared for CY 2015.

The report highlighted BSP's membership for the year under review – the BSP recorded a total of **TWO MILLION FOUR HUNDRED FIFTY FIVE THOUSAND FIVE HUNDRED SIXTY SIX (2, 455, 566)** in General Membership for CY 2015. Of this figure, 2, 250, 526 represent the Scout Membership [KID, KAB, Boy, Senior and Rover Scout Sections], 155, 526 represent the total number of Unit Leaders registered, and 49, 515 represent the Lay and Volunteer Leaders.

Another highlight of the report was BSP's stellar performance during the 25th Asia-Pacific Regional Scout Conference held last November 2015 in South Korea.

- The BSP won its bid to host the 26th Asia-Pacific Regional Scout Conference in 2018;
- Atty. Wendel E. Avisado, Acting Secretary General of the Boy Scouts of the Philippines
 was elected as 1st Vice Chairperson of the Asia-Pacific Regional Scout Committee for
 CY 2016-2018;
- Scout Jayvy R. Gamboa, BSP's representative to the 8th Asia-Pacific Regional Scout Youth Forum won as the Vice Chairperson of the APR Young Adult Members Group. Similarly, Scout Gamboa won 1st Place in the 2015 Asia-Pacific Regional Award for Outstanding Scouts;
- Mr. Yasser F. Sarona, Program and Adult Resources Executive of the Field Operations
 Division and Mr. Bernando G. De Leon, National Commissioner for Community-Based
 Scouting were conferred with the APR Messengers of Peace Heroes Award;
- Three (3) members of the NEB were awarded with the APR Certificate of Appreciation for their performance as members of the different Sub-Committee of the APR Scout Committee:
 - o International Commissioner Dale B. Corvera (APR Program Sub-Committee)
 - VP for Mindanao Leo G. Lasacar (APR Adult Support Sub-Committee)
 - NEBM Jimmy Ang (APR Scouting Profile Sub-Committee)
- Mr. Danilo C. Asiaten was also awarded with the APR Certificate of Good Service.

Finally, SG Avisado, on behalf of President Binay, closed his report, saying, "Last year, as in the past, can be considered a very successful year. The year went on as smoothly as I expected. The leadership of the BSP made sure that the transition from private to government-controlled corporation would be as easy as one would think it should. It was hard at the beginning, our National Office staff spent sleepless nights to make things right. We were at constant scrutiny from various government agencies like the Commission on Audit, which, to me is but normal and just. With the help and cooperation of our National Office staff, we came to learn the business in government-run offices. My friends, I would also like to take this opportunity to thank them – our National Office Directors and Executives, Regional Scout Directors and Regional Field Scout Executives, Council Scout Executives and Officers-in-Charge, and all the unsung heroes of the BSP, for helping our ship sail through rough waters. We made it to the shore. Now is the time to move on to the next step. The rest is up to us."

"We have achieved more than our targets! This is all, thanks to all of you."

After the report, the Presiding Officer inquired for questions, comments and clarifications relative to the Report of the National President.

Dialogue with the President and Open Forum

3.6. A query was posted by Mr. Jose P. Henson, Auditor of the Local Council Executive Board of Camarines Sur about the Grant-in-Aid Program, 'Wapakaganda ng binigay na ulat na ginawa ng ating Secretary General, lalong lalo na po yung sa ibibigay na isang milyong piso (PhP 1,000,000.00) para sa bawat Local Council. Ngunit sana po, kung maari lang po sana, ay i-simplify ang mga requirements at mga hinihingi, kasi po napakarami at napakahirap ng mga pinaggagawa at hinihingi sa amin. Kung ibibgay iyan, ibigay na lang.'

The guery was loudly applauded by the conference delegates.

SVP Pagdanganan stated that the gentleman from Camarines Sur, along with other delegates with the same line of thought, must take into consideration that the Boy Scouts of the Philippines is no longer a private organization, but is already a government-owned and controlled corporation. As such, the BSP is bound to adhere to the tedious and bureaucratic procedures the government.

'Iyang mga kailangang mga dokumento, hindi po namin ginawa yan sa National Executive Board. Hindi po yan ginawa ng ating Pangulong si Jejomar Binay, hindi po yan ginawa ni WEA [referring to Secretary General Wendel E. Avisado], kung hindi ay tagubilin po yan ng gobyerno, ng DBM at COA, 'SVP Pagdanganan added.

SG Wendel E. Avisado also alluded to the question and added some points, on top of SVP Pagdanganan's statement.

'Naunawaan ko po ang inihahayag ng ating kasamahang taga Camarines Sur Council. Alam niyo po, we are now a GOCC. Maaring sa lebel niyo po [sa Local Council] ay wala pa at hindi pa kayo napapasukan ng Commission on Audit, pero kami po sa National Office, mayroon pong nakatalaga sa aming Resident Auditor ng Commission on Audit, and the COA Central Office has even constituted an Anti-Fraud Team that looks carefully into the operations of the BSP over the previous years,' he stated.

He further added that the guidelines are there to help out the Local Councils in terms of facilitating the request for release of the money. "These are GOVERNMENT requirements, NOT our requirements. Sana po ay maintindihan ninyo," SG Avisado reiterated.

The Presiding Officer assured the conference delegates that the BSP is doing everything in its capacity to resolve the matter. Similarly, the BSP maintains its position not to remit any dividends to the National Government for the funds of the BSP is only held in trust, the funds belong to the members. Furthermore, the BSP is in no position to remit dividends as it does not receive any money or any form of remuneration from the National Government.

3.7. Another question was raised by a conference delegate [the identity could not be identified due to the poor quality of the voice recording]. He requested the BSP National Office to hold "crash courses or trainings" to all Local Councils about the government procurement system so as to equip everyone with the technical knowledge about government services.

The Presiding Officer directed SG Avisado to answer the question.

"Thank you for the suggestion. Alam niyo po ginawa na namin yan eh, tanungin niyo po lahat ng Local Councils. Ginawa na po ng BSP yan noong nakaraang taon. Kaya naman po ang pakiusap namin sa lahat ng Council Scout Executives, eh, please look after your Local Councils and explain to them the new processes, most especially the compliance to the government procurement system," SG Avisado answered.

Immediately after SG Avisado answered the question, Mr. Francisco B. Aniag, Jr., Council Chairperson of the Local Council Executive Board of Bulacan shared the way they handle such things in Bulacan Council, and their strong opposition to the entry of the Commission on Audit in their council, and their refusal to submit to COA's audit jurisdiction.

"Gusto ko lamang pong ipahayag, bilang Council Chairman ng Bulacan Council, ang amin pong posisyon sa Bulacan, hanggang sa ngayon, contrary to others, hindi po kami naniniwala na ang Local Council ay can be considered part of BSP's organic function, sapagkat ang [Local] Council po ay hindi part, hindi organic sa Boy Scouts of the Philippines. Ang [Local] Council ay binigyan lamang ng charter ng BSP, therefore, we are not [part of the] Boy Scouts of the Philippines."

He further continued, "Sa amin po sa Bulacan, apat na beses nang nagpadala ng auditor ang COA, hindi po namin sila tinatanggap, ang tanging sinasabi namin, kung kinakailangan, ay hihingi kami sa Regional Trial Court ng declaratory relief also. Palagay ko, para malaman natin talaga kung ang Local Council ay sakop ng COA, eh i test natin ito sa korte."

Finally, he concluded, "I am on the firm belief, that we [Bulacan Council] are not subject to COA's audit jurisdiction because we are not part of the Boy Scouts of the Philippines, we are just a chartered [Local] Council of the Boy Scouts of the Philippines."

"It is because of this that I am making a motion, for the National Council to pass a resolution, on behalf of the entire Boy Scouts of the Philippines, na ibalik natin ang ating pasasalamat, pagkilala, at pagbigay ng utang na loob sa ating mahal na Pangulo, Vice President Jejomar Binay, para sa kanyang dalawampung taon, sa pangununa, pamumuno at pabibigay ng malasakit para sa mga kabataan sa papamagitan ng Boy Scouts of the Philippines. Nais ko rin po sanang idagdag na sana magkaroon ng deklarasyon ang National Executive Board, ng isang espesyal na araw na kung saan ang buong Boy Scouts of the Philippines ay maihayag ang ating pasasalamat, pagkilala sa ating National President Jejomar C. Binay."

This was well taken by the Presiding Officer and immediately acted upon pending actions in order of importance. He ruled for the conference delegates to settle the Report of the National President prior to entertaining any other motions.

3.8. Governor Antonio H. Cerilles, Council Chairperson of Zamboanga del Sur – Pagadian City Council and Member of the National Executive Board was recognized.

"Since [former] Congressman Aniag was already endorsing Vice President Binay as President, then why don't we as the Boy Scouts of the Philippines endorse Vice President Binay as President? I think that's the best," he said.

He further added, "I don't know why we are being audited by the Commission on Audit. Yes, we are a GOCC, but we do not receive any funds from the government. Our actions are being questioned by the auditors, but this is the BSP, this is volunteerism. Eh binabastos na ang Presidente natin ng ganito. Why don't we support his cause for Scouting?"

Finally, Governor Cerilles seconded [former] Congressman Aniag's motion.

However, the Presiding Officer reiterated his earlier ruling, 'That is well taken, but the ruling of the Chair is for us to settle first, the approval of the Report of the National President before we could tackle any other order of business."

3.9. Atty. Eugenio V. Jurilla of the Local Council Executive Board of Quezon City then obtained the floor. He raised a motion to approve the Report of the National President, in order to proceed with the discussion and other ancillary motions from the floor. The same was duly seconded on the floor.

Hearing no objections from the floor, the Presiding Officer approved the Report of the National President, as delivered by SG Wendel E. Avisado, for and on behalf of Vice President Jejomar C. Binay.

3.10. *On Chairman Francisco B. Aniag, Jr.'s Motion*. The Presiding Officer then re-stated another pending question – Chairman Aniag's motion requesting the National Council to

pass a resolution of gratitude to Vice President Jejomar C. Binay for his outstanding and exemplary contribution to the Boy Scouts of the Philippines. The motion was earlier seconded by Governor Cerilles.

Prior to resolving the motion. Another question was raised by a conference delegate relative to COA's audit jurisdiction. However, the Presiding Officer sternly stated that he will follow procedures and resolve the pending question first prior to entertaining any further discussions. The Presiding Officer resolved the technicalities. He then directed Chairman Aniag to re-state his motion. The latter then acceded.

Hearing no further objections and discussions, the motion was unanimously carried.

3.11. The Presiding Officer then recognized the delegate who sought to obtain the floor earlier. The distinguished gentleman was from Metro Manila South Council, and stated that he is a professor of financial management, for the record.

He clarified that the Commission on Audit does not meddle on the affairs duly approved by the NEB. He stated that what the COA is looking into is only insofar as the use, disbursement and liquidation of funds is concerned. He stated that there is no need for the Local Councils to claim that they can are hard in following the procedures because the COA is after them. "Hindi natin dapat gamitin ang COA na dahilan para takasan ang proseso; bagkus, dapat makipagtulungan tayo sa COA kung papaano mapapabuti at maisasaayos ang ating mga transaksyon sa ating mga Local Councils," he added.

The Presiding Officer then exclaimed, "Alam niyo po, sana po ang magkausap kayo ng COA. Sinubukan na po natin iyan, umabot na po tayo sa Korte Supreme. Hayaan niyo po, isang araw, mag-uusap po tayo."

With the time closing in, the Presiding Officer duly noted the statement from the distinguished gentleman from Metro Manila South Council.

However, SG Avisado obtained the floor just to clarify the statement coming from the gentleman from Metro Manila South Council. He stated that there are separate audit teams at the level of the BSP National Office, the BSP Regional Offices, as well as the 121 Local Councils. "We have separate audit teams. What we are saying at the National Office is sundin niyo yung COA. Kami naman po sa National Office ay hindi pinapakialaman ang inyong mga financial transactions sa Local Councils sa kadahilanang kayo po ay may sariling audit team din mula sa COA."

3.12. Another query was raised by Mr. Eulalio P. Cortes of Surigao del Norte Council. He requested for the BSP to sit down with the Central Office of the Department of Education to discuss in full and in length, the collection of registration fees and membership of students and pupils to the Boy Scouts of the Philippines, so as to aid Local Councils in their membership campaigns.

This was duly noted by the Presiding Officer and requested the Directors of the Finance Division and the Field Operations Division of the BSP National Office to look into this and to meet with Mr. Cortes.

3.13. Engr. Leo G. Lasacar, Vice President for Mindanao of the National Executive Board then raised a concern. "Kagabi, masarap ang buhay natin, pero ngayon dahil sa COA, masakit na ulo na natin. Buti na lang, magaling ang host council."

He then raised a motion requesting the National Council to pass a resolution of appreciation to the Province of Pangasinan for hosting the 60th Annual National Council Meeting.

The Presiding Officer, SVP Pagdanganan was quick to respond. "Mayroon po tayong time para diyan bukas ng hapon. Kaya naman po, may I request you to raise the same motion tomorrow afternoon, [former] Vice Governor Lasacar."

Having covered all the items in the agenda, and with no further matters to discuss, the Presiding Officer adjourned the 1st Plenary Session at exactly 1051H.

The 2nd Plenary Session of the 60th Annual National Council Meeting was called to order at 1100H, with Hon. Harmes S. Sembrano, Regional Chairperson of the CLR Regional Scout Committee, Council Chairperson of the Local Council Executive Board of Tarlac, and Provincial Board Member of the Provincial Government of Tarlac as the Presiding Officer.

The agenda for the 2nd Plenary Session were:

- 1. Presentation of the BSP Strategy Map: VISION 2025
- Motivational Talk on the Conference Theme, "Growth and Stability"
- 3. Report of the Committee on Nominations
- 4. Election of the Four (4) Regular Members of the National Executive Board
- 5. Announcement of the Results of the Election
- 6. Oath Taking

1. Presentation of the BSP Strategy Map: VISION 2025⁷

The 2nd Plenary Session began with the presentation of the new strategic directions of the Boy Scouts of the Philippines. From July 2014 until September 2015, the Boy Scouts of the Philippines convened for several times, the Executive Committee of the National Executive Board and the Senior Management Staff of the BSP National Office to prepare and initial draft of the BSP Roadmap 2020 and the Strategic Performance Management System (SPMS) of the organization.

From October until December 2015, the Directorial and Executive Staff of the BSP National Office had already submitted the BSP Strategy Map: Vision 2025 and was initially approved by the National Executive Board.

And on the occasion of the 60th Annual National Council Meeting, the BSP presented the BSP Strategy Map: VISION 2025.

The Presiding Officer, Hon. Sembrano, then recognized the presenter, Engr. Rogelio S. Villa, Jr., Acting Deputy Secretary General of the Boy Scouts of the Philippines.

Prior to the beginning of his report, he mentioned that copies of the BSP Strategy Map: VISION 2025 were included in the conference kit, for reference.

DSG Villa started strong. "One of the great features of the Boy Scouts of the Philippines is that it always has the opportunity to constantly renew itself. Each year, we have a new opportunity to take the best of our past, add all the talents and energies that our members, volunteers, lay leaders and professionals bring into the organization, and rededicate ourselves to the pursuit of developing the young people to create positive changes in their communities. This interaction between the past and the present, the young people and the pool of volunteers, lay leaders and professionals, will help lead us to a fuller understanding of our organization's purpose and to a capacity to endow all our endeavors with greater meaning," he passionately stated.

He stated that with the advent of the second century of Scouting in the Philippines, a new strategy was adopted by the NEB – the BSP Strategy Map: VISION 2025.

The BSP Strategy Map: Vision 2025 outlines the strategic objectives and the focus areas that the Boy Scouts of the Philippines will be undertaking over the course of the next ten (10) years in order to achieve its Major Final Outcome – *Membership Growth.* It emphasizes a comprehensive approach in pursuing reforms and covers all facets of the organization: from personnel, to resource management, to internal processes and systems and to our renewed mission and vision

The Strategic Roadmap is divided into three (3) trienniums – 2016 to 2018, 2019 to 2021 and 2022 to 2024. It puts into play the approaches that will be considered and undertaken in order to measure and align BSP's intangible assets to achieve superior performance and maximum efficiency.

The new Vision and Mission of the Boy Scouts of the Philippines was presented:

Vision Foremost in preparing the youth to become agents of change in

communities, guided by the Scout Oath and Law.

Mission To help the youth develop values and acquire competencies to

become responsible citizens and capable leaders anchored on

the Scout Oath and Law.

The BSP Strategy Map: VISION 2025 carries the new Strategic Priorities:

Young People. Scouting is an educational movement, a movement of young people that must continue to be relevant in today's society, so it must keep itself abreast with the rapid changes and modernization, undergo self-examination in the light of the emerging and contingent educational philosophies and approaches. It gives young people the opportunity to develop their skills and acquire competencies necessary to survive in an increasingly complex and challenging world. Activities offered must be challenging, enjoyable and geared towards quality advancement in order to attract, train and retain members.

Adults in Scouting. The Adults in Scouting are key actors in the delivery of quality, relevant and equitable youth program for the young people. They represent the principal component in the realization of the vision of Scouting for the future. Well-trained, well-equipped, effective, educated, self-directed, motivated, task-oriented and performance-based, intuitive and highly competitive adults are essential to the survival, stability and integrity of the Movement. As a learning organization, it is therefore imperative for the Boy Scouts of the Philippines to establish a framework for the growth and development of adults in Scouting and for each Local Council to provide sustainable capacity mechanism for its program and adult resources development.

Community Involvement. Every Scout is actively involved in the communities and regularly engages in community service projects and initiatives, and share their experience to inspire others. Scouting also engages the government and other sectors of the society to pursue the

establishment of community-based Scouting units in order to reach out to the youth, the indigenous people, the street children, children in especially difficult circumstances, people with disabilities, and other stakeholders, actively working to welcome all individuals without distinction.

Resource Management. Effective and efficient deployment and allocation of resources assures the stakeholders of the organization's financial stability and self-reliance. The benefits should not only linger at the national level, but should also redound to all the Local Councils.

Organizational Excellence. The governance of the Boy Scouts of the Philippines should be transparent, accountable and efficient and clearly linked to its overall strategy, focused on achieving Membership Growth as its Major Final Outcome. Organizational Excellence raises the bar of excellence in membership development and strengthens the capacity of the Local Councils to improve communication strategies, marketing and public relations, accurately portraying Scouting's image as leaders of positive change. It also focuses on Governance, Performance Management, Risk Management and Disaster Response. To achieve this, roles and responsibilities of the personnel and the offices at all levels of the organization should be clearly defined and understood, ensuring synergy across all levels of the Boy Scouts of the Philippines.

DSG Villa ended his presentation with a strong call to action, "Ladies and Gentlemen, this is the BSP Strategy Map: Vision 2025, and this is the future of the Boy Scouts of the Philippines – an organization that continuously reinvents itself to better serve the young people, the Scout Movement and contribute to nation building. An organized entity that evolves to adapt to the changing times, emphasizing social justice and freedom for all. And although this organization will transform significantly in the years to come, the Scout Leaders and members, shall remain truthful to the Scout Oath and Law, emphasizing integrity above all."

After the report, the Presiding Officer thanked DSG Villa. Then a motion to approve the Report of the Deputy Secretary General and the BSP Strategy Map: VISION 2025 was raised on the floor. The same was duly approved by the conference delegates.

With no objections, the BSP Strategy Map: VISION 2025 was unanimously approved by the National Council.

2. Motivational Talk on the Conference Theme, "Growth and Stability"8

The next speaker was Atty. Adel Tamano, the Vice President for Public Affairs and Communications of The Coca-Cola Far East, Ltd. (TCCFEL).

"For more than eighteen years now, Coca-Cola has always been a proud partner of the Boy Scouts of the Philippines. Over the years, together – we have implemented programs that positively impact the well-being of the Filipino youth through the search for Ten Outstanding Boy Scouts; and the well-being of our environment through the Go Green! Go for the Real Thing Program," Atty. Tamano said as he began his speech.

He shared that he was a former Boy Scout, a Senior Patrol Leader at the Jose Abad Santos Memorial School in Quezon City. "I have always believed that whatever little success I have, was all because of the values that I learned as a Boy Scout," he continued.

The goal of the Coca-Cola Company, beyond the refreshing beverage that consumers enjoy, is to achieve water neutrality by year 2020 by returning every drop of water used in the manufacturing of Coca-Cola beverages.

The Boy Scouts of the Philippines and the Coca-Cola Company continue to find innovative ways to create shared value for the organization and the communities they serve.

Towards the end of his speech, Atty. Tamano assured the BSP of Coca-Cola's support towards developing the Filipino youth.

After his speech, a Certificate of Recognition was presented to Atty. Tamano.

3. Report of the Committee on Nominations

The Report of the Committee on Nominations was delivered by its Chairman, Mayor Dale B. Corvera, the International Commissioner of the Boy Scouts of the Philippines.

In order to appraise the delegates with the pertinent provisions of the National By Laws pertaining to the nominations for regular membership to the NEB, he cited Article V, Section 5 of the National By Laws which provides:

"Information on Nominees. All proposals for nomination shall be submitted in writing to the Committee on Nominations for its recommendation so as to be received by the Committee at least four (4) weeks prior to the opening of the National Council Meeting. This Committee shall be given full information concerning all possible candidates. During the deliberations of the committee, it shall meet in an executive session, and on request of any member, voting for nominees for the National Executive Board may be by secret ballot.

This Committee shall submit a list of nominees containing not less than twice nor more than thrice the number of positions to be filled. Nominations on the floor may be allowed by majority vote of the members of the National Council present at the meeting, provided that such person nominated on the floor has been previously nominated but not considered by the Nominations Committee." (emphasis supplied)

Chairman Corvera reported that the Committee on Nominations convened on 18 January 2016 to review the qualifications of all candidates who intends to run for regular membership to the National Executive Board. The following individuals, whose names are stated below have been found qualified to run as Regular Members of the National Executive Board, and have been accepted and endorsed by the Committee on Nominations, viz:

Chairman Corvera then reported that there are only a total of six (6) nominees for regular membership to the National Executive Board and such is not in conformity with the provisions of Article V, Section 5 of the National By Laws, primarily, "xxx This Committee shall submit a list of nominees containing not less than twice nor more than thrice the number of positions to be filled. xxx"

He clarified that the BSP National Office had exerted any and all efforts necessary in order to give the Local Councils ample time to submit their nominations. But despite the efforts, none of the Local Councils, or even members of the National Executive Board submitted any additional nominations.

He then submitted and endorsed the Report of the Committee on Nominations to the Committee on Elections chaired by Atty. Arturo V. Umbac, for resolution.

4. Election of the Four (4) Regular Members of the National Executive Board

The Presiding Officer then called on Atty. Arturo V. Umbac, Chairman of the Committee on Elections to render his report, resolve pending issues and facilitate the smooth, clean and orderly flow of the elections.

Chairman Umbac then took the podium and acknowledged and accepted the Report of the Committee on Nominations, on behalf of the Committee on Elections.

Chairman Umbac reported that during the recently concluded Regular Meeting National Executive Board held last 17 February 2016, prior to the start of the 60th Annual National Council Meeting, two (2) of the nominees expressed their intention to withdraw their candidacy for regular membership.

"Mayor Allan L. Rellon of Tagum City Council and Mr. Ireneo C. Aquino, Private Sector Representative, formally and officially extended their intentions to withdraw from the elections, and were duly accepted by the National Executive Board," he reported.

There were mixed reactions from the conference delegates upon hearing this – some were cheering, some were clapping, other expressed their disgust by shouting "boos." Nevertheless, such act was a democratic process.

"In view of this withdrawal, we are left with four candidates, namely Francisco B. Aniag, Jr., Wendel E. Avisado, Jose Ma. C. Gastardo and Leo G. Lasacar." He continued further, "Since we are limited to elect four regular members to the Board, in accordance with our National By Laws, were are just limited to these four candidates now."

To officially cast the lone ballot to formalize the elections and to satisfy the rules, Chairman Umbac requested Mr. Maximino J. Edralin, Jr., Member Emeritus of the National Executive Board and National Public Relations Commissioner to do the honor. "To formalize this, may I request NEB Member Emeritus Max Edralin, to formally cast the vote with your kind indulgence in representation of the group," he said.

Mr. Edralin acceded to the request and casted the lone ballot in favor of the nominees, who, are, in truth and in fact, winners by default.

Chairman Umbac then canvassed and tallied the votes, loudly, "The lone ballot contains the following - Francisco B. Aniag, Jr., Wendel E. Avisado, Jose Ma. C. Gastardo and Leo G. Lasacar."

He then requested the four candidates to come up on stage.

The Presiding Officer, Hon. Sembrano, then directed the four candidates to accede to the request of the Chairman of the Committee on Elections.

To cap the election process, the Presiding Officer directed Chairman Umbac of the Committee on Elections to declare the winners.

"By virtue of the power vested in me by the Boy Scouts of the Philippines as Chairman of the Election Committee, I hereby proclaim the following as duly elected - Francisco B. Aniag, Jr., Wendel E. Avisado, Jose Ma. C. Gastardo and Leo G. Lasacar," he proclaimed.

A loud applause was given by the crowd.

6. Oath Taking

The Oath Taking of the winners were deferred until the 1st Regular Meeting of the National Executive Board for CY 2016-2017, as requested by the members of the National Executive Board.

With no further matters to discuss, the 2nd Plenary Session was adjourned at exactly 1155H.

After the session was adjourned, the Officer of the Day then made some announcements relative to the conduct of the 2016 National Court of Honor and Awarding Ceremonies.

He reminded the conference delegates that the 2016 National Court of Honor will begin at 1400H, and requested all awardees to be on time, as names will not be called again.

Likewise, he reiterated that only those persons who have duly confirmed their attendance will be given their awards.

1. Presentation of the Philippine Scouting Centennial Award

The Awarding Ceremonies began with the Presentation of the Philippine Scouting Centennial Award.

The Philippine Scouting Centennial Award is an award given by the Centennial Celebration Committee of the National Executive Board during the 100 Years Celebration of the Introduction of the Scouting Program in the Philippines, to Scout Leaders who have served the Boy Scouts of the Philippines for 50 years and beyond. It contains the Philippine Scouting Centennial Medallion.

The Philippine Scouting Centennial Medallion was especially made by the *Bangko Sentral ng Pilipinas* [Central Bank of the Philippines]. The commemorative medallion is made up of Nordic "gold" (89% copper, 5% aluminum, 5% zinc and 1% tin) and is plated with 24K Gold, measuring 34.0mm in diameter, 2.4mm in thickness and weighs at about 15.0 grams. Only one thousand pieces (1000) were made and released.

The 3nd Plenary Session of the 60th Annual National Council Meeting was convened at 0849H. The Presiding Officer was the Vice President for Mindanao of the Boy Scouts of the Philippines, Engr. Leo G. Lasacar.

1. Presentation of the Conference Resolutions

Without any delay, the Presiding Officer immediately called on the Chairman of the Committee on Evaluations of the 60th Annual National Council Meeting, Mr. Ireneo C. Aquino to present the Conference Resolutions.

The following resolutions were presented by Chairman Aquino and were subsequently approved by the National Council:

1.1. **60**th **ANCM Resolution No. 2016-001**

A Resolution approving and confirming the release of **ONE MILLION PESOS (PhP 1,000,000.00)** per Local Council of the Boy Scouts of the Philippines (BSP) as one-time financial assistance thru the Grant-in-Aid Program (GIAP) chargeable from the proceeds of the share of the BSP in the Joint Venture Project with Alphaland Makati Place, Inc. (AMPI) as approved in the previous Annual National Council Meetings, subject to the availability of funds and the implementing guidelines, as well as to government accounting and auditing rules and regulations;

1.2. 60th ANCM Resolution No. 2016-002

A Resolution authorizing the National Office of the Boy Scouts of the Philippines (BSP) to use part of the proceeds of the share of the BSP in the Joint Venture Agreement (JVA) with Alphaland Makati Place, Inc. (AMPI) for the following:

- 1.2.1. support to operations to finance the separation pay *cum* benefits of the employees of the BSP who will be affected by the Rationalization Plan;
- 1.2.2. construction, repairs and maintenance of buildings and Scout camps;
- 1.2.3. capital outlay for the purchase of vehicles, equipment, furniture and fixtures;

1.3. **60**th **ANCM Resolution No. 2016-003**

A Resolution confirming the decision of the National Executive Board, per NEB Resolution No. 069, s. 2015, revising the policy on the Financial Assistance Program (FAP) in compliance with the audit recommendations of the Commission on Audit (COA) to discontinue providing financial assistance which are not related to Scouting activities and

to increase the financial assistance related to Scouting activities with the following schedule of benefits, viz:

To the highly esteemed members of the National Executive Board, Ladies and Gentlemen, Good Morning! The first time I came face to face with members of the National Council was in 1994. There, I came to realize the magnitude of my responsibility as head of the Noble Movement. I was caught in awe! Amazement and an overwhelming feeling of anxiety and excitement gave me endless Goosebumps, something that did not happen to me in my years in politics, as I read the year's accomplishment report.

Jumped to 2014, the year we advocated "Peace and Development Through Scouting." Yes, we become an active messengers of peace. The year was also marked as a great transformation when we focused our sights on membership growth thus, we can say that the year 2014 was the year of efficiency and stability. We shall stay stable forever. We shall not stop being efficient.

Let's go back to the year that was when our accomplishments fuelled our passion to do more and to excel further towards "Growth and Stability".

Altogether, we strived harder, and when I say we, it means You, I, along with our Scouting friends, brothers and sister, colleagues, partners, our benefactors, and yes, all volunteers who made up this organization. We have gone this far and we shall not rest on our laurels as long as we are all together in this endeavor. I shall thank you all for this commitment.

As we took our sight on membership growth, we slowly but surely gained our foothold to prepare the movement for growth and stability.

Indeed, 2015 opened too many opportunities for us to explore and learn as we evolved into an organization of the 21^s century.

I am truly honored and humbled to have each one of you as we go forward and seized every single moment towards Stability and Growth. No one, nothing can stop us now.

Let us all therefore take a look at the symbolic framework of our 2015 Annual Report cover. This is the beginning of a new journey toward the BSP Roadmap: Vision 2025 beginning this year until the year 2018.

Every single detail of this logo, each vibrant color, represents our new identity as we have gone through the process of Change and Transformation. You will get to know more about this in the next presentation.

Meanwhile, I invite everyone to join me reflect, look back, learn, grow together and celebrate our accomplishments in 2015. I am sure you will agree with me that the year 2015 is a successful year.

Major Final Output

Our six Key Strategic Priorities paved way to Membership Growth.

Six Key Strategic Priorities

Let me sum up each priority:

Quality management is anchored on the continued observance and adherence to the cycle of planning, implementing, monitoring and evaluation of the organization's short, medium and long-term strategic plans.

Capacity building focuses on improving the level of capabilities of the professionals and volunteers serving the Movement in various areas membership registration system, manual of operation and standard operating procedure, information and communication technology and other related fields.

Quality Program and Training for Young people and adult leaders this include our aim of opening Scouting to all segments of the society from the young members to adult leaders which would mean more interesting activities that would interest both of them.

Scout Membership

The Boy Scouting section continues to dominate the five sectional groups with a total of 99,745 registered members, thus garnering the biggest share of the pie chart with 41%. This is followed by the KAB section with 833,741 registered members, Senior Scout section with 435,911, KID Scout section with 141,665 members, Rover Scout Section with 14,835 and the Community-based scouting with 10,322 registered members. Our membership increased by 7.9%, posting an addition of 178,773 Scouts to the 2.25 Scouts registered in 2014. This years figure represents 106.8% accomplishment against the membership goal of 2.272M and a 32.3% achievement rate against the membership potential of 7.54M.

The Boy Scout section continues to dominate the five sectional groups with 992,745 registered members or 41% share. This is followed by the KAB Scout section with 833,741 registered members (34.3%), Senior Scout section with 435,911 (18%), KID Scout section with 141,665 (5.8%), Rover Scout section with 14,835 (0.6%) and the Community-Based Scouting (CBS) with 10,322 registered members (0.4%). Scout membership increased by 7.9%, posting an addition of 178,773 Scouts to the 2,250,526 Scouts registered in 2014. This year's figure represents 106.8% accomplishment against the membership goal of 2.272M, and a 32.3% achievement rate against the membership potential of 7.54M.

Adults in Scouting

We all know that Adults in Scouting refer to Unit, Assistant Unit and Leaders of Adults. They are the key volunteers managing the Langkay, Kawan, Troops, Outfits and Rover Circles. Leaders of adults specialize in leading the Unit leaders in managing he affair of the Scouting Committees at the sponsoring institutions, districts, councils, regions and national lever. These include Board members, committee chairpersons and members and lay leaders.

Some 155,525 Unit leaders from 87,760 Scouting Units lent their support and services to the Scouting Movement in 2015. The number of registered ULS an AULS in 2015 is 10.4% higher than the 2014 Adult membership of 140,856. The ration of UL to Scout now stants at 1:15 (one unit eader for every 15 Scouts). The number of registered lay leaders and volunteer leaders in 2015 is 49,515.

Regional Performance

The Bicol Region posted the highest membership growth in 2015, with 75,692 or an increase of 29,779 or 535 From 49,526 Scouts registered in 2014. However, it still remains at the spoat spot in terms of number of registered Scouts with rating of 47.3% against membership goal.

Southern Tagalog Region registered the highest number of Scouts in 2015 with a total of 467,729. This represents a 19% share in the overall Scout membership. The STR's Scout membership grew by 11% higher from 2014, adding 46,192 Scouts in 2015. It ranked second in membership performance against goal with rating of 128.6%.

Financial Assistance Program

Target vs performance

For calendar year 2015, The FAP Claims and Processing Unit targeted a total of 2,000 claims to be process, approved and released. As of December 31, 2015, at least 130% aforementioned target was achieved with an equivalent claims of 2,600 claims duly processed, approved and released or distributed to rightful claimants.

For the year under review, the aggregate value in pesos of the disbursed funds to cover the FAP claims processed, approved and released was **Php 6,891,706.37.** The distribution of claims per Scouting in terms of percentage is reflected in the pie chart. DISTRIBUTION PER NATURE OF CASE

As for the nature of claims, cases for In-patient Medical Reimbursement posted the highest figure in terms of the amount of cash assistance benefit provided to the claimants/beneficiaries with a total of P3.06M or an equivalent of 45% of the aggregate cash assistance benefit. It is followed by cases for Out-Patient Medical Reimbursement with P2.36M or 34% of the aggregate cash assistance. Here are other claims as per nature of the case: Accidental death – P.920M (13%; Natural death – .535M (8%); Dismemberment P.12M .18M).

Financial Assistance

Financial Assistance to Local Councils which have registered at least 20% of their membership potential.

In support of the major final output of the BSP which is membership growth, the BSP National Office will continue to provide financial assistance to local councils which have registered at least 20% fo their membership potential based on their official membership statistics ending Dec. 31 of year. In 2015, there were 81 Local Councils whose membership recruitment performance exceeded at least 20% of their membership potential, compared to 77 local councils which had registered beyond 20% of their membership potential. This is a clear manifestation htat many of our local councils are performing better every year and are taking extra effort in supporting the Major Final Output: membership growth of the BSP. Herewith is the existing scheme of financial assistance provided to Local Councils duly approved by the National Executive board in December 2014:

Consistent with the thrust of the BSP to further improve and develop the capacity and capability of its staff in performing their regular functions, the BSP conducted the 2015 Mid-year Performance review on July 7-8 at the BP International Training Center in Makiling, Los Banos, Laguna. The activity was participated in by 30 officers composed of the Senior Management Team, Regional Scout Directors and Executives.

25th Asia-Pacific Regional Conference

We made it to the International Scouting scene. We wowed them, we inspired them and we added more feathers to our international Scouting hat, a proof that the BSP is a force to reckon with in the global Scouting Movement. Here's how:

The BSP won in the bid to host the 26th Asia-Pacific Regional Conference in 2018; Our 2014 TOBS awarded, Scout Jayvy Gamboa of Batangas City Council, won the first place in the Search for Asia-Pacific Regional Outstanding Scout; Acting Secretary General Wendel E. Avisado, also a member of the Asia Pacific Regional Scout Committee, was elected s the 1st Vice Chairman of the WSB-PR Scout Committee for the year 2016-2018.

BSP PARD Executive Yasser F. Sarona and BSP National Commissioner for Community Based Scouting Bernardo G. De Leon were conferred the APR Messengers of Peace Heroes Award.

Four of our Board members were awarded the APR Certificate of Appreciation for Sub-Committee. The four are:

National Treasurer Boy Scouts of the Philippines

The Report of the National Treasurer was prepared by Director Pedro B. Penados and Acting Accountant Ermin R. Delim of the Finance Division.

Ladies and Gentlemen!

As the New Year unfolds, a promising future for the Boy Scouts of the Philippines is ahead of us. While we certainly have our ups and downs, we persevered and hurdled every obstacle that keeps getting in the way. We rallied with our cause in encouraging the youth to become good citizens. We became more equipped with the capability to continue with our goals in serving our country with competence and proficiency as can be gleamed from our past operations. My friends, with these words, let me present to you the Unaudited Financial Statements (currently being audited by the Commission of Audit as we speak today) of the Boy Scouts of the Philippines for the Year Ending December 31, 2015 with corresponding figures for the year 2014.

As of the December 2015, our total assets has increased by P22,027,498 or equivalent to 0.48%. The increase is from the aggregate results of the financial performance for the year 2015 with a total of P34,360,717 (please see cash flows) net of the obligations settled totaling P26,625,269 or equivalent to 19.90%. In addition, our ability to settle our debts has increased from P2 to P3 for every 1 peso liability of the BSP. This is very favorable to us as only a meager 2.41% of the total networth of the Organization is being funded by debt.

Our financial performance on membership registration have increased by 6.73% or equivalent to P8,628,233. For the year ending December 31, 2015 Southern Tagalog Region posted the highest membership registration with a total of P25.63 million, followed by Eastern Visayas Region with P20.09 million and Eastern Mindanao Region with 17.33 million (*The figure for the rest of the regions are shown in the graph*).

Comparatively for two years, however, it was Bicol Region that posted the highest membership increase with a total of 45.67% or equivalent to P1.32million, followed by Central Luzon with 10.62% or P1.581 million, next is National Capital Region with 9.89 % or P811 Thousand. The rest of the regions include:

- 4) Western Visayas Region with an increase of 9.47%
- 5) Southern Tagalog Region with 8.97%
- 6) Eastern Visayas Region with 8.07%
- 7) Northeastern Luzon Region with 7.28% and
- 8) Western Mindanao Region with 0.34%

Meanwhile, comparatively for 2014 and 2015 Eastern Mindanao Region and Ilocos Region have decreased by 3.37% and 0.11%, respectively.

Despite our setback in Makiling National Scout Reservation, which posted a loss for the period covering January – December 2015, our aggregate income derived from Income Generating Properties totaled P24,235,459, an increase of P5,652,350 as compared to last year's operations.

In addition, as of December 2, 2015, the BSP has received payment from Alphaland Makati Place, Inc. (AMPI) in the amount of P15,980,627.34 representing the proceeds from the sale of condominium units/parking slots owned by the BSP which are part of its 15% share from the BSP –AMPI Joint Venture Agreement, the details of which follow: (please refer to the PowerPoint)

Inspite of the initiative of the BSP to subsidize all National Office initiated training programs and seminars and activities, our total operating expenses has posted a decrease of P11,443,524. You will note that for the year 2015, we spent a total of 5,923,968 as subsidy in the conduct of scouting programs and activities: (please refer to the PowerPoint).

On the whole, I would like to add that we have now further strengthened and solidified our organization and resources towards achieving Growth and Stability. We have continued to increase our membership and have started to reap the fruits of our investments. I wish to extend my thanks and appreciation to our National Executive Board headed by our President Jejomar Binay for painstakingly and ably steering our organization to what it is now today. And I thank even more all our local councils for your continuing support and cooperation for it is through our united stand and combined efforts that we have reached this far driven by our strong belief in the tenets and principles of Scouting and our unqualified commitment to do our share for the sake and benefits of our young members.

From July 2014 until September 2015, the Boy Scouts of the Philippines convened for several times, the Executive Committee of the National Executive Board and the Senior Management Staff of the BSP National Office to prepare and initial draft of the BSP Roadmap 2020 and the Strategic Performance Management System (SPMS) of the organization.

From October until December 2015, the Directorial and Executive Staff of the BSP National Office had already submitted the BSP Strategy Map: Vision 2025 and was initially approved by the National Executive Board.

Today, we are finally seeing the fruits of the sleepless nights and the hard work of the pool of professional staff, volunteers and lay leaders of the Boy Scouts of the Philippines in charting the course of this great organization.

To present and give us an overview of the BSP Strategy Map: Vision 2025, let us welcome on stage, the man behind the high-adventure programs of the Boy Scouts of the Philippines and the long-time Team Leader of the BSP Strategic Planning Process, and its continuing innovation in its day-to-day operations, the Acting Deputy Secretary General of the Boy Scouts of the Philippines and concurrently, the Director of the Field Operations Division, Engr. Rogelio S. Villa, Jr.

DSG Villa:

The beginning of the new century of Scouting in the Philippines was welcomed with a profound sense of renewal, reaffirming our strategic actions to create positive changes and make transformative contributions in our communities. As we step further into the second year of our second century, we look back at how our hopes, our efforts and our aspirations for the young people to interact with the great tradition of the Scout Movement, to produce an ever greater vibrancy in the Boy Scouts of the Philippines.

Scouting in the Philippines is now 102 years old, and the vitality of the BSP continues to depend on an energetic and dynamic interaction between the old and the new, between tradition and change, between the young people and the young at heart, between the great ideas and artifacts of the past and the new ideas and innovations that characterize the contemporary life.

One of the great features of the Boy Scouts of the Philippines is that it always has the opportunity to constantly renew itself. Each year, we have a new opportunity to take the best of our past, add all the talents and energies that our members, volunteers, lay leaders and professionals bring into the organization, and rededicate ourselves to the pursuit of developing the young people to create positive changes in their communities. This interaction between the past and the present, the young people and the pool of volunteers, lay leaders and professionals, will help lead us to a fuller understanding of our organization's purpose and to a capacity to endow all our endeavors with greater meaning.

We have stood the test of time and despite all the challenges that threaten and portend our stability as an organization, we always overcome, we always outwit and outplay every hurdle. And so, at the beginning of the new century of Scouting in the Philippines, a new strategy was adopted – the BSP Strategy Map: Vision 2025, highlighting our commitment to pursue a genuine transformation program founded on good governance and performance excellence.

The BSP Strategy Map: Vision 2025 outlines the strategic objectives and the focus areas that the Boy Scouts of the Philippines will be undertaking over the course of the next ten (10) years in order to achieve its Major Final Outcome – *Membership Growth.* It emphasizes a comprehensive approach in pursuing reforms and covers all facets of the organization: from personnel, to resource management, to internal processes and systems and to our renewed mission and vision

The Strategic Roadmap is divided into three (3) trienniums – 2016 to 2018, 2019 to 2021 and 2022 to 2024. It puts into play the approaches that will be considered and undertaken in order to measure and align BSP's intangible assets to achieve superior performance and maximum efficiency.

Our overall aim is the continuous growth in our membership to more young people. We are institutionalizing reform efforts by providing a solid, rational and long-term basis for our programs, projects and activities.

It is for this reason that we have recrafted our Vision – daring, yet fitting for the largest, the oldest and the most vibrant youth organization in the country – **Foremost in preparing the youth to become agents of change in communities, guided by the Scout Oath and Law.**

In order to attain our Vision, our recrafted mission statement encompasses what we want to do now — To help the youth develop values and acquire competencies to become responsible citizens and capable leaders anchored on the Scout Oath and Law.

Our mission will sustain our diverse membership – from the young people in cities and provinces, to the indigenous peoples, the underprivileged, the children in especially difficult circumstances, the differently-abled, among others. Our programs and activities are informed by tradition and inspired by a deeper understanding of the past, willed by innovation and creativity, but the rudimentary of which are our **Core Values, the very foundation of our existence – the Scout Oath, the Scout Law, the Scout Motto and the Scout Slogan**. We will provide our members with every opportunity for holistic growth, and an environment that involves youth participation in our decision-making processes at all levels. This is duality by single action.

Our Strategy Map is centered on two (2) **Themes – Development Orientation and Good Governance.** This is where the BSP need to excel in order to sustain growth.

Development Orientation is primarily anchored on the learning and development orientation of the program and the training pool, our technical people. This orientation is posited to be a motivational state that depends on the degree to which learning and development are relevant to the organization. We will be reframing the ways in which work and work context variables influence learning and development behavior in the Boy Scouts of the Philippines.

The other theme of our Strategy Map is Good Governance. We are moving forward towards a participatory, consensus-oriented, accountable, transparent, responsive, effective and efficient, equitable and inclusive, and an organization that strictly conforms to the standards of the law. It focuses on the efficient management of financial and human resources and development. This orientation will further improve BSP's image as a character organization, manage performance and capacitate the entire workforce of the BSP.

Under each theme, there are specific key strategic priorities that will enable us to fulfil our shared vision for the Boy Scouts of the Philippines. For Development Orientation, we have **Young People, Adults in Scouting and Community Involvement.** For Good Governance, we have **Resource Management and Organizational Excellence.**

Allow me to briefly elucidate on each point.

Young People. Scouting is an educational movement, a movement of young people that must continue to be relevant in today's society, so it must keep itself abreast with the rapid changes and modernization, undergo self-examination in the light of the emerging and contingent educational philosophies and approaches. It gives young people the opportunity to develop their skills and acquire competencies necessary to survive in an increasingly complex and challenging world. Activities offered must be challenging, enjoyable and geared towards quality advancement in order to attract, train and retain members.

Adults in Scouting. The Adults in Scouting are key actors in the delivery of quality, relevant and equitable youth program for the young people. They represent the principal component in the realization of the vision of Scouting for the future. Well-trained, well-equipped, effective,

educated, self-directed, motivated, task-oriented and performance-based, intuitive and highly competitive adults are essential to the survival, stability and integrity of the Movement. As a learning organization, it is therefore imperative for the Boy Scouts of the Philippines to establish a framework for the growth and development of adults in Scouting and for each Local Council to provide sustainable capacity mechanism for its program and adult resources development.

Community Involvement. Every Scout is actively involved in the communities and regularly engages in community service projects and initiatives, and share their experience to inspire others. Scouting also engages the government and other sectors of the society to pursue the establishment of community-based Scouting units in order to reach out to the youth, the indigenous people, the street children, children in especially difficult circumstances, people with disabilities, and other stakeholders, actively working to welcome all individuals without distinction.

Resource Management. Effective and efficient deployment and allocation of resources assures the stakeholders of the organization's financial stability and self-reliance. The benefits should not only linger at the national level, but should also redound to all the Local Councils.

Organizational Excellence. The governance of the Boy Scouts of the Philippines should be transparent, accountable and efficient and clearly linked to its overall strategy, focused on achieving Membership Growth as its Major Final Outcome. Organizational Excellence raises the bar of excellence in membership development and strengthens the capacity of the Local Councils to improve communication strategies, marketing and public relations, accurately portraying Scouting's image as leaders of positive change. It also focuses on Governance, Performance Management, Risk Management and Disaster Response. To achieve this, roles and responsibilities of the personnel and the offices at all levels of the organization should be clearly defined and understood, ensuring synergy across all levels of the Boy Scouts of the Philippines.

The entire strategy map is covered by five (5) perspectives which the BSP viewed as vital components of organizational development to attain excellence — **Social Impact, Stakeholders, Internal Processes, Learning and Growth and Financial.**

Social Impact refers to how the BSP creates positive changes in the life of its members and the communities they live in. It is how the BSP perceive to be an effective contributor to the development of the Philippine society. We focus on the responsiveness of our programs to the needs of our members, as well as the benefits derived from the program to the community.

On Social Impact. Peace, Environment and Development Education, Image Management and Community Service and Development Projects and Community-Based Scouting will contribute towards generating a positive impact for the Boy Scouts of the Philippines, were our thrusts and programs are responsive and contingent on the needs of the communities and the benefits that will be derived from such undertakings.

Stakeholders refers to all those who believe in the cause and programs of Scouting, those who want to embrace Scouting as a way of life, they too, must be cared for by the organization, they too must be developed, nurtured and recognized. These are the youth, the adult volunteers, benefactors, supporters and friends of Scouting.

Two (2) focus areas were identified to benefit our Stakeholders. Personal Development and Quality Training will directly benefit our stakeholders. Our Adults in Scouting Policy clearly provides the guidelines in the management of adult resources, from recruitment, appointment, personal support and training, personal recognition and assessment. This will ensure that we develop our adults to acquire the competencies needed to fulfill their tasks. We will make sure that their contributions are being acknowledged and recognized, their skills are further nurtured and developed.

Internal Processes is one of the most important perspectives in our strategy map. This relates to the operational processes and systems that we are doing in order to ensure operational stability. The processes are being streamlined in order to maximize efficiency of the personnel and contribute to the overall growth and stability of the organization. Human resources then, is a primary factor which could directly affect effectivity.

On Internal Processes. Performance Management and Competency-Based Capability Building are areas that will further enhance, streamline and simplify office processes and procedures. The SPMS, once operational, will fairly assess and evaluate human resources and maximize their efficiency. A seamless internal processes and procedures will definitely enhance frontline services and vcontribute to organizational growth and stability.

Learning and Growth focuses on the intangible assets of the organization, mainly on the internal skills and capabilities of the employees that are required to support the value-creating internal processes. It describes how people, technology, and organizational climate combine to support the overall strategy.

On Learning and Growth. Risk Management, Management Development and Scouting to More Young People will contribute to the development of the personnel, lay leaders, volunteers and professionals. We will be raising the bar of excellence in membership development further strengthen the capacity of our Adults in Scouting – from National Local Councils on several facets.

Financial. The organizations financial stability and human resources will propel the BSP to successfully achieve its targets in 2025. We must adopt strategic financial and resource management policies and comprehensive development plan on utilization of properties to ensure that 20% of our corporate budget will come from these assets and become less dependent/reliance on membership fees – this will considerably support/help the finances of the Local Councils. We must establish good governance practices on accountability and transparency in the utilization and management of our resources in accordance with government rules and regulations.

On Financial. Accountability and Transparency, Optimization and Creation of Revenue Streams / Sustainability and Economic Viability will ensure the financial stability of the Boy Scouts of the Philippines and all its Local Councils.

Ladies and Gentlemen, this is the BSP Strategy Map: Vision 2025, and this is the future of the Boy Scouts of the Philippines – an organization that continuously reinvents itself to better serve the young people, the Scout Movement and contribute to nation building. An organized entity that evolves to adapt to the changing times, emphasizing social justice and freedom for all. And

although this organization will transform significantly in the years to come, the Scout Leaders and members, shall remain truthful to the Scout Oath and Law, emphasizing integrity above all.

We invest in education. In addition to the TOBS scholarships, we make education accessible to children in far flung communities through our Little Red Schoolhouse Program. In partnership with the Department of Education and the Philippine Business for Social Programs, we built more than 100 Little Red Schoolhouses nationwide so children will have a better chance to pursue their goals in life.

We also provide economic opportunities for women who are already pillars of our business. In 2010, we made a commitment to enable the economic empowerment of 5 million women entrepreneurs across the Coca-Cola value chain by year 2020. In the Philippines, our goal is to empower 200,000 women sari-sari store owners and operators through a program called STAR or Sari-Sari Store Training and Access to Resources.

Our sustainability journey is built on the same foundation as the Boy Scouts. It is about improving people's lives, addressing our collective challenges and creating enabling environments for the youth, women and communities to thrive so that no one will be left behind.

To end my message, I would like to wish the BSP National Council and the up and coming new member of the National Executive Board the best of luck and may we achieve the BSP Vision 2025. Good afternoon!

When I received the request to address the Court of Honor I did not hesitate to say YES because I am honoring the promise I made to my husband, Roger Vicencio, former Asst. Secretary-General and National Training Commissioner, before he passed away eight years ago. He said, *Huwag mong pababayaan ang Boy Scouts*, and which is why I am still here—serving the Boy Scouts, the organization we both love. And that is also the reason why I am keeping the title I love most—Mrs.—because I had a more difficult time getting the Mrs; it was easier for me to earn a full Professor title and a Ph.D. from the University of the Philippines. I had to join the Boy Scouts to become a Mrs.

On a more serious note, this afternoon we will recognize the achievements of ____ outstanding and honorable Scouters. Today, they will receive Scouting's highest recognition of honor the product of their excellent performance. Honor and Excellence are not only the hallmark of the awardees but they should be every Scouter's aspiration as members of the Scouting Movement.

I would like to leave with you, awardees, five messages. They are guidelines that will keep your feet planted firmly on the ground even as your heads are high above the clouds, basking in the honor that you very well deserve. My five messages are taken from the word EXCELLENCE, which can be broken down into five little words, and interpreted as in an anagram: X, CELL, EXCEL, EN, and LENS.

X in EXCELLENCE. The X in excellence symbolizes the X factor that makes you, dedicated and committed Scouters outstanding. Before, it was believed that there was only one intelligence, called the general or G factor. That is no longer true in education. There is an X factor and it is a mixture of different factors now recognized as Gardner's nine intelligences manifested by our awardees. and I know by many of you:

Intrapersonal intelligence Interpersonal intelligence Verbal/linguistic Environmentalist/naturalist Spiritual intelligence Musical/rhythmic Logical/mathematical Body/kinesthetic Visual/spatial

On the other hand, there are others who humorously classify people into wise and otherwise.

Mark of Excellence # 1: Know your talent. Remember: Nurture your excellence.

CELL in EXCELLENCE. The cell is the smallest unit of a group. All living things are made up of one or more cells that combine to form our body parts. You are like a cell. You cannot exist without others. You could not have excelled by yourselves only. You needed other people to help you get to the top— your Unit—be it Langkay, Kawan, Troop, Outfit, or Crew, the BSP, the Leaders of Adults who supervised you, and the Council officials, who supported you, and your families, who understood what you were doing and tolerated your absence during Jamborees, and other Scouting activities. All of them helped you in one way or another to deserve your award. Now, are you helping others get to the top, too? Are you helping others to excel? In other words, are you paying forward and paying back?

Let me share with you the analysis of the Filipino anthropologist, Dr. Felipe Landa Jocano, Sr. about the Filipino crab mentality *o isip-talangka*. Dr. Jocano taught Anthropology at the University of the Philippines and he required his students to do a one-semester research on the Filipino crab mentality. Contrary to what others believe, he said that the crabs are actually forming a pyramid so that they can get out of the basket. They are not really pulling each other down; they are actually helping each other up. It's not "I'll pull you down to where we are" but "Help us get to where you are." When the crabs have formed a pyramid, their sheer weight would topple the basket and they would all be set free. The story of the crabs is actually a metaphor for *bayanihan*. When you help somebody reach the top you will also be near the top. I hope that this knowledge will put an end to the negative connotation of crab mentality. And, by the way, the term is not of Filipino origin, but it originated in America, along the Mississippi River.

Remember the word TEAM – T-E-A-M. Work as a team and Together Everybody Achieves More.

Mark of Excellence # 2: Help others to excel.

Remember: Work as a TEAM and Together Everybody Achieves More.

EXCEL in EXCELLENCE. Excel means to rise, be better, greater, or more superior. It is a symbol for "being prepared to do your best for service." The difference between ordinary people and Scouters are in our three mottoes—"be prepared to do your best for service." We Scouters do what is expected of us—"to be prepared to do our best for service. We meet our obligations and responsibilities fairly and squarely. We can be counted on in an emergency. Scouters make the world more livable, for our spirit of service is summed up in our three mottoes "be prepared to do your best for service.

Mark of Excellence # 3: Be prepared to do your best for service. Remember: To whom much is given, much is also expected. EN in EXCELLENCE. An en in printing is a space 1/12 of an inch. It's very, very small. In the mark of Excellence it is the symbol of humility.

How many of you think you are humble? Please raise your hand.

Humility is something we should always pray for, but never thank God that we possess, because the moment you say you are humble, you are no longer humble. Right?

Humility is what we think of ourselves. It is recognizing our limitations. It is saying "I'm sorry" or "It's my fault." It is forgiving a person who has apologized. It is acknowledging that there's always another person who can do things better than us. It is saying "Congratulations!" and "Thank you" even to our boys.

Mark of Excellence # 4: Be humble of heart.

Remember: God exalts those who humble themselves.

LENS in EXCELLENCE. Using the shortened language of texting, lens is a glass or other transparent substance spreading rays of light passing through it. It's a symbol for being a model. People may close their ears to advice, but they keep their eyes open to example. Our fellow Scouters, including our Scouts, are watching us all the time—especially now that you will be recognized in this Court of Honor. If we do something good, we are inviting them to come and follow us. Unfortunately, if we break the law, they will follow us, too, and then excuse themselves by saying, "Well, if my leader could do it, why couldn't I?" Consciously or unconsciously we spread light by our good example. So, let our light shine!

Mark of Excellence # 5: Be a model for others.

Remember: Our good example is like a light for the whole world.

To summarize, the 5 Marks of Excellence are—

1. X: Know your talent and nurture it.

2: CELL: Work as a TEAM and help others to excel.

3: **EXCEL**: Be prepared to do your best for Service

4: EN: Be humble of heart.

5: LENS: Be a model for others.

And altogether, they spell EXCELLENCE!

As a Scouter, I am very proud of you. You demonstrate the commitment, determination, resourcefulness, self-reliance, and excellence that make up the Scouting ethos.

My message for all the other Scouters—the future awardees— Carry on what the greatest Scouter started—reflect His goodness and His love through Scouting.
