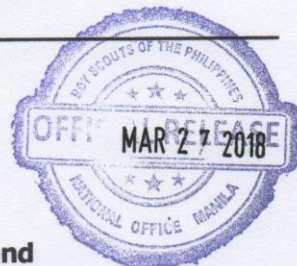

### NATIONAL OFFICE MEMORANDUM No. 22 Series of 2018



**TO :** Regional Scout Directors, Council Scout Executives and Officers-In-Charge

**SUBJECT :** PROMOTION OF DILG CIRCULAR NO. 11 SUPPORTING THE BOY SCOUTS OF THE PHILIPPINES

The Boy Scouts of the Philippines recognizes the significance of the issuance of DILG Memorandum No. 11, s. 2018 as a golden opportunity that will usher in the unprecedented growth and reach of Scouting in the Barangays and communities,

In order to fully reap the benefits of the support of the DILG and the local government units nationwide, all BSP Regional Offices and Local Councils are hereby mandated to perform the following:

#### A. BSP REGIONAL OFFICES

1. Conduct an initial and exploratory meeting with the DILG Regional Director to find out how to operationalize the substance of the DILG Memorandum;
2. Request for the name and contact details of the DILG Regional Scouting Coordinator, which shall be submitted to the BSP National Office; and,
3. Initiate effective mechanisms of coordination and other activities with DILG field offices in order to establish strong partnership with them.

#### B. BSP LOCAL COUNCILS

1. Conduct an initial and exploratory meeting with the DILG Provincial Director to find out how to operationalize the substance of the DILG Memorandum;
2. Request for the name and contact details of the DILG Provincial and Field Offices Scouting Coordinators which shall be submitted to the BSP National Office;
3. Initiate effective mechanisms of coordination and other activities with DILG Provincial Office and other field offices in order to establish strong partnership with them;
4. Identify programs and projects where the Provincial DILG Office can participate;
5. Pay courtesy calls on all Governors, Mayors and Barangay Chairmen to seek support pursuant to the DILG Memorandum Circular;
6. Appear and speak before the Sanggunian to pay courtesy call to and request the support of the Vice Governors, Provincial Board Members, Vice Mayors, City/Municipal/Barangay Councilors;
7. Encourage all LGU officials and employees to be members and wear the uniform of the Boy Scouts of the Philippines; and
8. Conduct orientation meetings with the Barangay Chairmen and their respective Kagawads on the implementation of the Barangay Scouting Program.



All BSP Regional Offices and Local Councils shall submit, together with the list of Scouting Coordinators, a comprehensive report on the actions taken consistent with this directive, and such other initiatives to maximize the implementation of the DILG Memorandum Circular, including feedback on the result of exploratory meetings, orientation meetings, commitments or pledges of LGU and DILG officials, and courtesy calls.

Attached is the report format which shall be used by the BSP Regional Offices and Local Councils for this purpose and submitted to the BSP National Office c/o the Field Operations Division every 15<sup>th</sup> of the Month.
