Mindanao:	Pasonanca Park, Zamboanga City

The activity aims to develop the participants' life skills and 21st century leadership capabilities through team building, cooperative learning, group dynamics, and creative problem-solving and decision-making.

The target participants are rover scouts, rover leaders, and adult leaders and volunteers who will meet the minimum qualifications set by the BSP.

Participation of public and private schools shall be subject to the no-disruptionof-classes policy stipulated in DepEd Order (DO) No. 9, s. 2005 entitled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith. This is also subject to the guidelines on the conduct of co-curricular and extracurricular off-campus activities for public and private schools stipulated in DO 66, s. 2017 entitled Implementing Guidelines on the Conduct of Off-Campus Activities, and the no-collection policy as stated in Section 3 of Republic Act No. 5546, An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities (Ganzon Law).
