

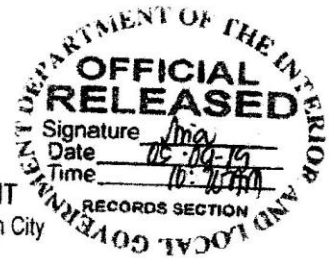

SUBJECT : BOY SCOUTS OF THE PHILIPPINES 63RD NATIONAL
ANNUAL COUNCIL MEETING (ANCM) ON MAY 29-31, 2019
IN PILI, CAMARINES SUR

The Boy Scouts of the Philippines will hold its **63rd Annual National Council Meeting (ANCM)**, to be held on May 29-31, 2019, at the Camarines Sur Capitol Convention Center, in Pili, Camarines Sur, with the participation of local government officials who are members of the BSP National Executive Board, including DepED Regional Directors and DepED Schools Division/City Superintendents.

In accordance with Section 1, Article V of the BSP Constitution and By-Laws under Republic Act No. 7278, the purpose of the said ANCM is to present the reports of the National President and National Treasurer, elect four (4) regular members of the National Executive Board, propose possible amendments to the BSP By-Laws, and conduct the National Court of Honor. The Awarding Ceremonies of the Tribute to Scoutmaster, Ten Outstanding Local Council Chairmen and Ten Outstanding Local Commissioners are ancillary events.

Local government officials who are members of the BSP National Executive Board are authorized to attend the said Council meeting, on official business. The payment of registration fee, if any, and travelling expenses may be authorized, chargeable against local government funds, subject to the availability of funds, and the usual accounting and auditing rules and regulations.
