

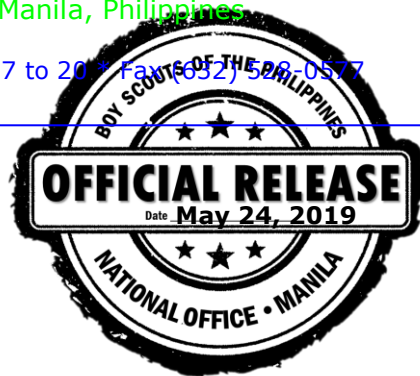

**TO : Regional Scout Directors, Council Scout Executives and Officers-In-Charge**

**SUBJECT : EUROPEAN JAMBOREE 2020 - POLSKA**

1. We are pleased to inform you that upon the invitation of the World Scout Bureau-European Scout Region and the Europe Region of WAGGGS, the Boy Scouts of the Philippines (BSP) is organizing Contingent Team to represent the Philippines in the **EUROPEAN JAMBOREE 2020** hosted by the Polish Scouting and Guiding Association.

2. The basic information of the said events are as follows:

Date:	27 July – 06 August 2020
Venue:	Gdansk (Sobieszewo Island), Poland
Age:	14-17 year old
Deadline:	October 15, 2019

3. **Qualification of Participants:**

#### Scout Applicants

- Duly registered Scouts
- Must be physically fit and in good health
- The Scout must have attended BSP Regional/National Jamboree/APR Scout Jamboree

#### Scout Leader Applicants

- Duly registered with the Boy Scouts of the Philippines
- Must be physically fit and in good health
- The applicant must have attended BSP Regional/National Jamboree/APR Scout Jamboree

#### International Service Team Applicants

- Duly registered with the Boy Scouts of the Philippines
- IST applicant should be 18 years of age
- Must be physically fit and in good health
- The IST applicant must have attended BSP Regional/National Scout Jamboree as National Service Team (NST)

**Mode of Selection:** The National Office, BSP reserves the right to select the members of the delegation based firstly, on qualification and secondly, on a first come first served basis.

All prospective participants are required to attend the pre-jamboree training to be conducted by the BSP National Office.

4. **Documentation:** Qualified participant must be a holder of a valid Philippine Passport, which can be obtained at the Department of Foreign Affairs (DFA) Consular Office located in various cities/provinces nationwide.

5. **Visa Requirements (deadline for submission of requirements 15 Oct 2019):**

- Visa Application Form completely filled up
- A Valid Philippine Passport (old and new), undamaged
- Three (3) Passport Size Colored Photos with White Background
- Supporting documents needed during interview (all originals)

**A. For Adults**

- Bank Certification/s with Bankbook or Statement of Account for 3 months
- Certificate of Employment – including applicant's position, working record and monthly/annual income and approved leave of absent
- If self-employed Business Name/Permit or SEC Registration
- Birth Certificate and Marriage Certificate (if married) with NSO security paper
- Latest Individual Income Tax Return (ITR)
- If government employee, Authority to Travel is required

**B. For Scouts**

- DSWD Certificate to Travel for Minors
- Affidavit of Support and Consent of Parents
- Parent Bank Certification/s with Bankbook
- Parent Certificate of Employment – including applicant's position, working record and monthly/annual income
- If self-employed Parent Business Name/Permit or SEC Registration
- Parent Income Tax Return (ITR)
- School ID and Certification of Enrolment/Registration
- Birth Certificate with NSO Security Paper
- Parent Marriage Contract with NSO Security Paper

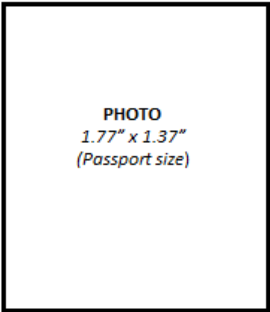
