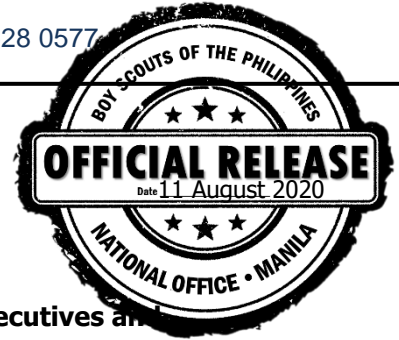

SUBJECT : Corrigendum to National Office No. 48, s. 2020 re 2020 Search for the Outstanding Boy Scouts

- Also, please be informed that the initial screening for the TOBS Nominees will be conducted by the TOBS Secretariat at the National Office. After which, qualified nominees will be returned to their respective Local Councils. From there on, the qualified nominees will have to submit pertinent documentary requirements as specified in the search criteria and will be endorsed by the Local Councils to their respective Regional Office for the Regional Search.
