- 2. The Scout Youth Forum, as part of the Youth Development Program of the Boy Scouts of the Philippines, is organized to fill in the need and the clamor for youth participation in the decision-making process of our organization. It is a place for information, training, and concrete experience of discussing and acquiring a deeper understanding of various issues. It is also a source of inspiration by providing a contract with new people, fresh ideas, innovative thoughts, different experiences and working methods.
- 3. **General Qualifications**. For an individual to qualify for the National Scout Youth Forum, the following standards must be satisfied:

## For Senior Scouts:

- a. Must be currently registered Senior Scouts from Grade 7 to 11
- b. Must have been elected in prior levels of the Scout Youth Forum

#### For Accompanying Adults:

- a. Must be currently registered Adult Leaders
- b. Must have been officially designated by the Regional Office
- c. Must be fully conversant about the Scout Youth Forum

4. **Participation**. In order to cope up with the challenges associated with a virtual forum, each Region shall follow the indicated number of participants:
