


SUBJECT : **ADDITIONAL ONE (1) VOTE FOR EVERY TEN THOUSAND SCOUTS MEMBERSHIP AS OF 31 DECEMBER 2020**

- Article IV, Section 3 of the BSP National By-Laws provides that each duly chartered Local Council shall be represented in the National Council by the Local Council Chairman and the Council Scout Commissioner and such other delegates it may designate. Each Local Council represented in the annual or special meeting of the National Council **shall be entitled to four (4) votes plus one (1) vote for every ten thousand (10,000) of their Scout membership...**
- In this connection, here are the Local Councils whose Scout memberships are within the 10,000 membership-threshold and are entitled to additional vote/s for the election of the Regular Members of the National Executive Board during the Online 64th Annual National Council Meeting on 29 May 2021, to wit:
