SUBJECT : 2021 OBSERVANCE OF 18-DAY CAMPAIGN TO END VIOLENCE AGAINST WOMEN (VAW)

3. The schedule of the seminars are as follows:


November 25, 2021, Thursday (9:00A.M.-12:00 P.M.)	-	Basic Concepts on VAW/GBV
