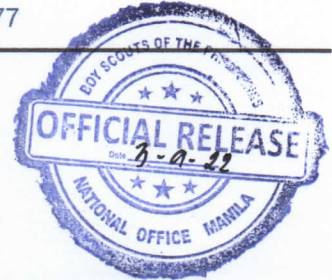

1. The Boy Scouts of the Philippines is pleased to announce the conduct of 2020 National Scout Youth Forum with the following details:



3. For an individual to qualify for the National Scout Youth Forum, the following standards must be satisfied:
 - A. Must be currently registered as a Senior Scout
 - B. Must be a holder of at least Outdoorsman Rank
 - C. Must have been elected in prior levels of the Scout Youth Forum
4. Accompanying Adult Leaders must be currently registered, officially designated by the Regional Office, and is fully conversant with the Scout Youth Forum.
