



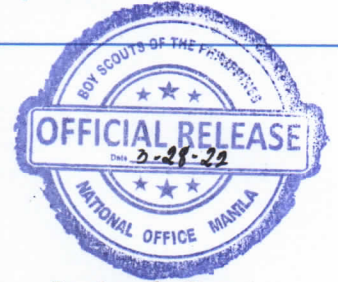


### NATIONAL OFFICE MEMORANDUM

**TO :** Council Chairpersons, Council Scout Commissioners, Regional Scout Directors, Council Scout Executives and Officers-In-Charge

**SUBJECT :** **ONLINE 65<sup>TH</sup> ANNUAL NATIONAL COUNCIL MEETING (ANCM)**

1. Pursuant to the provisions of R.A. 7278 and the By-laws governing the Boy Scouts of the Philippines, the National Executive Board (NEB) has approved the conduct of the **65th ANNUAL NATIONAL COUNCIL MEETING (ANCM)** on **26-28 May 2021** through Online via Zoom Platform.
2. **Purpose.** As provided in Section 1, Article V of the BSP National By-laws, the National Council shall hold an Annual Meeting not later than 31 May of each year, at such time, date and place as may be determined by the National Executive Board for the purpose of receiving the annual reports of the officers, electing the regular members of the National Executive Board, ratifying any proposed amendments to the BSP Bylaws (if any) and transacting such any other business as may properly come before the meeting.
