SUBJECT : **NEW PROCEDURE IN THE PREPARATION OF SCOUT
ADVANCEMENT STATISTICAL REPORT**

1. Under the Governance Commission for GOCC s (GCG)'s requirement for the agency's Performance Evaluation Scorecard (PES), assessment and validation of performance are made monthly and/or quarterly through submission of scorecard report along with the supporting documents as attachment.
2. While the Scout Advancement Statistical Report is prepared in a monthly and quarterly basis, the present computation is done in a commulative manner, which includes Scouts who advanced during the one-year period. This formula in computing the number of Scout advancement does not therefore reflect the actual figure of Scouts who advanced to next higher rank for the particular month/quarter.
3. In order to harmonize the requirement of GCG under Strategic Measure #3 – Percentage of Scouts Advanced to Next Higher Rank, all concerned are hereby advised to use the attached revised new form and procedure in the preparation of their respective monthly Scout Advancement Statistical Report effective January 2023.
4. This new procedure in computing the number of Scouts who advanced to next higher rank will only take into consideration **the actual number of Scout advancement for the month according to rank and section**, i.e., KAB Scouting (Young USA, Growing USA and Leaping USA), Boy Scouting (Tenderfoot, 2nd Class, 1st Class, Outdoorsman), Senior Scouting Explorer, Pathfinder, Outdoorsman, Venturer, Eagle Scouts) Rover Scouting (Yellow, Green, Red, Blue Quadrants, Chief Scout's Nation Builder).
5. This memorandum supersedes NO Memo No. 43 s. 2012 Re: Revised Procedures in the Preparation of Scout Advancement Statistical Report and NO Memo No. 44 s. 2012 Re: Monthly Scout Advancement Report Form and all other related memoranda, circulars and issuances inconsistent herewith.
